### **/FW #1720 Grand Rapids Loses Post Home to Fire** By Hugh Quinn, Commander of Post #1720





On 7 March 2020 an electrical fire, that started in the basement of the adjoining building, took out Ponti-Peterson Post 1720 of Grand Rapids, Mn. The fire started out small and what appeared to be a quick job for area firefighters turned into a long defensive fire fight that in the end required the assistance of 7 additional companies. Over the course of 15 hours the building where the fire originated was nearly completely gutted by the fire, and the VFW Post lost its entire second floor with the fire creeping down the second floor walls.

Roof rafters and roofing almost completely burned and what didn't burn collapsed onto the floor. While the blaze was kept to the 2nd floor of the post, the water damage that occurred is catastrophic.

The local public utilities measured over 700,000 gallons of water poured into the two buildings

and an unmeasured amount came from the Blandin Paper Company through a 6 inch hose.

The response from the community was amazing. Before the fire had been put out, city officials, local businesses, non-profits, and individuals had already pledged their support to rebuild. Within three days, the community had two fundraisers organized and the boys from the club had rented a new temporary home three doors down from their old one.

As of today's date, we are on-line in a rented space two doors down from the old club Due to city codes we are unable to do much of anything in the space and because its designated mercantile, we are now a T-Shirt retailer. We have been allowed back in the building, and started the process of recovery and

We as a 501(c)19 are included in the \$350 billion dollar Small Business Administration (SBA) loans available that the government just approved.

Here are some loans you can apply for and do it quickly. Just GOOGLE them!!

#### PPP – Paycheck Protection Program

Announced by the Small Business Administration (SBA)-This is a program that can provide a 100% federally guaranteed loan to businesses with less than 500 employees. If employers maintain their payroll, the loans would be forgiven, and ultimately become a grant to the applying organization. Only approved by your bank and guaranteed by the government – **do not go to the SBA web site – Go to your Bank.** 

#### Economic Injury Disaster Loans (EIDL) & Emergency Economic Injury Grants

This program provides an emergency advance of up to \$10,000 to small business and most non-profits harmed by COVID-19. An organization must first apply for an EIDL and then request the advance. The advance does not need to be repaid under any circumstances. Other terms apply.

# **Words From Your National Council Member**

In my efforts to try to keep the members of the Minnesota VFW and Auxiliary abreast of what is on the table at the National level I will impart some information in each edition of the Gopher Oversea'r but as always, some of the information may be stale or even archaic. For that I apologize in advance and hope you'll acquiesce.

Most recently I attended the VFW Washington Conference with the Minnesota delegates. The National Council of Administration met as a part of the Conference where several matters were discussed and brought to the floor for action. One of the most thoroughly discussed issues proposes an overhaul of the ceremonial aspects of the present Voice of Democracy and Patriots Pen program. Rather than bringing all the State winners into Washington as a part of the Legislative Conference, the organization would recognize the top 5 winners at the National Convention and then invite all the State winners to the Spirit of America Leadership seminar put on by Freedom's Foundation at Valley Forge, PA. This trip is currently offered but paid for by the Departments. Under the proposed change the cost of this trip would be borne by the National Organization. The other State winners would be recognized at a Department event by the National representative. Even after absorbing the cost of this tour the proposal would save the organization close to \$232,000. The

motion to adopt this recommended change was tabled until the meeting scheduled for July at the National Convention.


A number of other issues were raised at the Council meeting and were met with less discussion. The majority of the items were what are often referred to as "housekeeping" things, such as a continuing review of the organization's annual budget; a review of the National Travel Policy, and reports from the Adjutant General, Quartermaster General, Executive Director of the VFW Washington Office, and Directors VFW Legislative Service of and National Veterans Service. Additionally, reports were given by some of the program directors and other Committee Chairmen.

### VFW Demands Congress Hold VA Accountable for Failure to Grant Benefits, Post 9/11 Veterans Suffering Toxic Exposures

'It's time for Congress to change the framework for providing benefits to individuals who suffer from conditions associated with toxic exposures' March 04, 2020

#### WASHINGTON -

Veterans of Foreign Wars National Commander William "Doc" Schmitz called for "accountability for failure to grant benefits to Vietnam and Post-9/11 veterans suffering from toxic exposures" during a special joint hearing of the Senate and House Veterans' Affairs Committees today.

The VFW expressed its frustration with the Department of Veterans Affairs' lack of urgency in providing benefits to individuals who suffer from conditions associated with toxic exposures, especially when there is science to back up veterans' claims.

"The VFW proposes a permanent, comprehensive, and evidence-based framework of granting presumptive benefits for toxic exposure," said Schmitz. "Veterans who were exposed to burn pits and now suffer from pulmonary conditions and rare cancers should not have to wait decades for benefits – like Vietnam veterans did."

The VFW proposed process of granting benefits would require VA to acknowledge the existing research linking these conditions to their service and establish benefits if supported by the science.

"It's important to ensure veterans who suffer from adverse health conditions related to toxic exposure receive benefits, but acknowledging the science also ensures VA can improve the care that nearly 80 percent of VFW members use and prefer," said Schmitz.

Vietnam veterans diagnosed with bladder cancer, Parkinson-like symptoms, hypertension and other conditions that scientists have said are connected to Agent Orange remain without health care and benefits.

"It's unacceptable that the list of conditions presumed to be associated with Agent Orange exposure does not include bladder cancer, Parkinson-like symptoms, hypertension, and other conditions that scientists have said are connected to military service," said Schmitz. "The VA keeps making excuses for not acknowledging it. As a Vietnam veteran, I will not sit idle as my comrades struggle to survive without the care and compensation they deserve."

Schmitz reminded committee members that the VFW has led or played a major role in every reform or expansion of veterans benefits since the institution of the VA.

#### Defense Act Ends 'Widow's Tax'

President Donald Trump's signing of the National Defense Authorization Act of 2020 on Dec. 20 terminated the long-standing "widow's tax" of surviving spouses of troops.

The law (P.L. 116-92) allows surviving spouses of military troops who died during active-duty service or retirees who died from a service-connected cause to keep all compensation from the government. Prior to the new law, surviving spouses who received a Dependency and Indemnity Compensation (DIC) paid a dollar-for-dollar offset from their Military Survivor Benefit Plan (SBP).

The law eliminates the dollar-for-dollar offset of survivor benefit payments, a longstanding VFW priority goal.

"This is a momentous victory for the more than 65,000 military spouses who endured the tragic loss of their husband or wife who paid the ultimate sacrifice," said VFW Commander-in-Chief William "Doc" Schmitz. "Without these extraordinary spouses fighting in the trenches with us, the termination of the widow's tax may not have been possible." For many survivors, the offset completely eliminated their SBP payments and threatened their financial security.

"There is no justifiable reason why money should have ever been stripped away from our military spouses," Schmitz said.

In May 2019, VFW led the first roundtable discussion with other veterans' service organizations, congressional staffers and surviving spouses affected by the offset to create a legislative campaign to eliminate the widow's tax.

VFW National Legislative Service Associate Director Kyle Kalman said the signing of the 2020 Defense budget "rights a wrong" for military widows and widowers, who were "forced to endure" an offset of survivor benefit payments, as well as other types of compensation.

"We commend the leadership in Congress and the coalition of veterans and survivor organizations that fought alongside us for their commitment to the 65,000 surviving military spouses," Kalman said. "Our military widows and widowers deserved this victory."

#### VA Publishes Proposed Regulations to Improve the Program of Comprehensive Assistance for Family Caregivers

The U.S. Department of Veterans Affairs (VA) will publish a proposed rule in the Federal Register

whether it resulted from an injury, illness or disease- defining what it means to be in need of personal care services, and ensuring that the eligibility criteria capture the personal care service needs of Veterans and Servicemembers with cognitive or neurological impairment or mental health conditions, among other things. Additionally, VA is proposing changes to the stipend payment definitions methodology, for financial planning and legal services and procedures for revocation and discharge, to include advance notice requirements aimed at improving communication between VA and PFAFC participants. We owe a tremendous debt of gratitude to caregivers who work tirelessly to provide critical support for our nation's Veterans," said VA Secretary Robert Wilkie. "This proposed regulation would improve the assistance we provide to help

ensure our most vulnerable Veterans can stay in their homes with their loved ones for as long as possible."

VA's Caregiver Support Program is the first of its kind and addresses the complexity and expense of keeping loved ones out of institutions and at home with their families who provide personalized care. The program offers unparalleled support services including training, peer mentoring, respite care, a telephone support line and self-care courses for caregivers of all Veterans enrolled in VA health care who need personal care services. The regulations are part of a broad effort to strengthen PCAFC in advance of a planned expansion under the MISSION Act which expanded eligibility for PCAFC to eligible Veterans from all eras, beginning with those who incurred or aggravated a serious injury in the line of duty on or before May 7, 1975. Two years after the first phase

of program expansion, PCAFC will include eligible Veterans who were seriously injured in the line of duty between May 7, 1975 and Sept. 11, 2001. Prior to expanding, VA must fully implement an information

March 6 that would improve and standardize VA's Program of Comprehensive Assistance for Family Caregivers (PCAFC) and ensure the program regulations reflect changes required by the VA MISSION Act of 2018.

A component of the Caregiver Support Program, the PCAFC was established in 2011 to provide additional benefits including a monthly stipend for qualifying family caregivers of eligible Veterans who were seriously injured in the line of duty on or after Sept. 11, 2001.

In the proposed rule, VA seeks to standardize eligibility by expanding the definition of serious injury to include any serviceconnected disability- regardless of technology (IT) system required by the MISSION Act.

In October 2019 VA launched a commercial off-the-shelf IT system and expects to complete deployment in late summer or early fall of 2020. The department also standardized operating procedures for the Caregiver Support Program, provided new training for staff and caregivers and is boosting operational capacity through hiring of additional staff. These changes are necessary as VA prepares to expand PCAFC.

Our veteran community is comprised of every demographic in America - rural, suburban, and urban; religious from and of every faith - and non-religious as well as this great country of ours allows and protects; from our Native Americans who have served so well (would the battles of the South Pacific have been won without our Code Talkers?) to hyphen-Americans from virtually every region and country across the world; immigrants yearning to be free, shedding the hyphen, and melting in the pot to become Americans. Gays? Yes. Straights? Yes. Conservatives, Moderates, Liberals and Independents? Yes. You name the demographic, and they are our Brothers and Sisters that answered the call of duty and earned the title: "Veteran."

As VFW



Members, we know the benefits are not adequate for if they were, we would have no need for National, Department, District nor Post Legislative Officers or programs.

I write this whilst social distancing at home, not knowing when my Post will again schedule meetings nor open its doors, nor when District, Department, and National events will occur. We do not know when the state legislature will reconvene nor what changes will result from this crisis. What I do know is that more than ever, a phone call or an email is important. Our Elected Representatives need to hear from us, and they need to hear now. The message they hear from us needs to be delivered with the respect we've been given. We need to be respectful while being insistent that Veterans, and our families receive what we have earned and deserve.

We also need our members to make our voices heard in our communities. While at home practicing "social distancing" or, if it comes to it, sheltering in place, take the time to write a thoughtful and respectful letter to the editor of the local paper about an issue confronting Veterans and our families. Follow it up with a phone call. Need some suggestions on what to write? Call or email! I urge all members, all veterans, to be respectful in all our activities, especially on social media and especially if you hold an elected or appointed position. These are trying times, and now, more than ever, is the time to show leadership through respect.


With the loss of these Heroes goes the history, the stories of what they saw and endured, and sacrifices

inventory.


There are two potential plans moving forward. In the event that the insurance company's structural engineer says the building is still sound, we may end up tearing off the second floor, gutting the building to the studs and rebuilding.

In the event the building is condemned, we are looking at building new at a cost of \$225-\$250 per square foot. We'll need a minimum of 4500 square feet and we'll be keeping it to one floor. We have decent insurance but we will still need to raise up a good chunk of money.

# Martin County Memorial Site Receives Famous Bell Cobra Attack Helicopter 327

#### January 10, 2020

#### MINNSOTA-

Martin County's Veterans Memorial Site will permanently display an actual Bell Cobra-Fixed Wing Attack Helicopter, AH-1-66-F-15327. U.S. Army records show this very helicopter is internationally famous for serving the U.S. Army in both Vietnam and Laos from 1986 to 1971. Even though five states were vying for the acquisition of this Cobra, due to the hard work of Minnesota State and Local Veterans and Volunteers the Cobra was awarded to Martin County.

Many Veterans remember how the Cobras saved their lives when they were outnumbered by the enemy. Our local Veterans have lived the story. In Vietnam on various dates, Cobra-327 was hit by enemy fire at least twelve times. Bell's armor plating saved the flight crew from mortal inflictions. Missions included: Armed Escort, Recon Missions & Battle Support. In 1971. Cobra 327 saw service in Laos at the Battle of Lam Son 719, one of the deadliest battles of the war https://www.businessinsider. com/uncovering-the-story-of-oneof-the-vietnam-wars-bloddiest-battles-2015-1. Flying this helicopter were Members of the U.S. Army, 7th Squad, 17th Calvary, C Troop. Cobra 327 was mortally shot, and it was a ride the pilot will never forget. Yes, the pilot made it back alive to this day. The Gunner unfortunately died from Agent Orange at age 37.

new helicopters, the Cobra 327 was retired to public service for the Kern County Fire Department in California to fight night fires because it could see through the smoke with its military infrared scanners and locate people. The Cobra has the nickname THE SNAKE, because of its maneuverability. Burn marks are still visible from the fires where it landed, which shows how close to the fires

When the U.S. Army received

the Cobra could maneuver. Martin County's Veteran Memorial Committee is currently restoring this Cobra in Fairmont, MN., returning it to the likeness of 1971. This detailed restoration work has been in progress since the fall of 2019. We invite you to visit the restoration process, in all the various stages by contacting any MCVM Committee Members. The Dedication Ceremony is set for August 1, 2020 featuring a parade, many VIP's, Military Personnel (both active and retired), and family members of those erving on this very helicopter. # **VA Launches Medication Disposal Program**

#### MINNEAPOLIS-

The Minneapolis VAHCS is pleased to announce a new safety initiative to help veterans, their families, and VA staff safely dispose of unwanted and unneeded medications. Beginning Friday, January 24, the main medical center will have an onsite a receptacle for the disposal of controlled substance medications such as opioids, noncontrolled substance prescription medications, and over-the-counter medications.

Increasingly prescription drug abuse is recognized as a public health problem in the United States. Over 6% of people aged 12 and older have misused prescription medications in the last year. Misuse of medications such as opioids, anti-depressants, anti-anxiety medications, stimulants, and other medications can lead to serious behavioral and other health problems, addiction, and even death.

According to the VA's National Center for Medication safety:


- 62% of teenagers who abuse prescription drugs abuse them because they are easy to find around a family member's house
- More than <sup>1</sup>/<sub>4</sub> of people who started abusing drugs in the past year began by abusing prescription medications
- 78 people die every day of opioidrelated overdoses
- Unintentional death from prescription medication overdose

has surpassed deaths from motor vehicle accidents in the US

Medication take-back programs such as the one at the Minneapolis VAHCS can help reduce the risk for these and other serious consequences of prescription medication misuse and abuse. Medication take-back programs such as the one at the Minneapolis VAHCS can help reduce the risk for these and other serious consequences of prescription medication misuse and abuse. As suicide is an important public health problem, suicide rates are linked to the availability of lethal means. As part of this model there is increasing support for reducing the availability of lethal means to prevent suicide. The installation of a medication disposal recepticle is just one intervention designed to support means reduction.

The Minneapolis VAHCS program for onsite medication take back is free to our veterans, their family members, and our staff. We hope it will be well used!

Note: For patients receiving care at our CBOCs or sites outside of the main medical center, other options are available. TakeAway envelopes are available through pharmacy and at our CBOCs for mailing back unwanted or unneeded medications. Take-back receptacles are also located at many community sites. #### **VFW State Pistol Competition Runs Out of Time**

With over a year of planning and anticipation, the new three-tier VFW State Pistol Competition was upon us. Unfortunately, a lack of experience and coordination with the Range uncovered a major problem --- TIME!

On February 22, 2020, Elk River – Rogers VFW Post 5518 invited all Participants of the Competition to a Reception at their VFW Community Center in Otsego, Minnesota. Although the turnout was small, everyone enjoyed themselves and many stories were shared.

At 8:00 AM on Sunday, February 23, 2020, registration for the Competition opened at Target Sports in Rogers, Minnesota. A total of twentyeight (28) 'shooters' signed in for the three levels of competition. A large number of participants elected to shoot more than one level. There were eighteen (18) shooters at the .22 Caliber level, twenty-one (21) shooters at the Open level and only four (4) shooters at the Optics or Assisted level. Coffee and Rolls were available.

Range Orientation began at 9:00 AM. Post Commander Dennis Maddox welcomed everyone and introduced State Commander Chad Solheid and State Senior Vice Commander Curt Hermanson. Representatives of Target Sports briefed all participants on the Rules of the Range and how the Competition would be conducted.

The .22 Caliber level began shortly before 9:30 AM - ten shooters on the Range per cycle. After two cycles, the Open level began their firing sequences. This is where we ran out of time! We had reserved the Range from 8:00 AM to Noon. It was almost Noon when the Optics/Assisted level entered the Range to compete. Hospital Representative. In 1990, the Minnesota Military Order of the Purple Heart had him to serve as their State Adjutant and Hospital Representative. Although he continued to work with Veterans, Jimmy 'sort of' Retired to a 'quiet' life at Marine on the St. Croix Veterans Camp.

Jimmy was a Life Member of Vasatka-Goers VFW Post 6690 in Mendota, Minnesota. He served as their Post Commander from 1981-1983 with All-State Post Commander Honors in 1982. He served as the Fourth District Commander in 1987 -88 with All-State District Commander Honors. He was the State Chief of Staff in 1988-89. At the 1991 State Convention in East Grand Forks, Jimmy was elected as State Judge Advocate. He worked through the State Chairs and was elected as State Commander at the 1994 State Convention in Rochester. He was a member of the American Legion, Military Order of the Purple Heart, Marine Corps League, Masonic Lodge and a Zurah Shriner. Like a former Claims Director (and his Boss for a number

of years) said, "Jimmy wore his Heart on his sleeve". Jimmy, at times, had a somewhat 'abrasive' personality. Some called him a 'little banty roster'. Obviously, Jimmy (sometimes) rubbed people the wrong way ... Encounters with Jimmy were sometimes intense - if not demanding. A few people got to know the REAL Jimmy Connolly. He argued intensely and Loved Deeply! He was dedicated to his fellow Marines... His fellow Veterans... Jimmy was known to jump from his helicopter in a 'hot LZ' and 'fireman carry' a wounded Marine to the safety of that helicopter. He had the same dedication to his Veterans – he would NEVER LEAVE ANYONE **BEHIND!** This article is difficult Jimmy was a Great to write... Friend, someone with whom I spent 'treasured' time with (and embarrassing moments)... some Unfortunately, like all things in this world today... one thinks there is always tomorrow. I only wish we could have had more time... You will be missed, you have left a 'void' that few can fill. Rest in Peace my Friend - God knows you have EARNED your place in Heaven...




