

## **Update on New MN Veterans Homes**

The Minnesota Department of Veterans Affairs (MDVA) is proud to be opening new Homes to better serve our Veterans, their families and communities. Our goal is to ensure that Veterans are admitted as soon as possible to a highly satisfying, engaging and safe facility. However, the opening of three new Veterans Homes in Bemidji, Montevideo and Preston is a complex process and has recently been delayed.

Construction delays on largescale projects are not uncommon; in this case, specifications have to be met exactly in order to ensure we meet the standards of the Minnesota Department of Health (MDH) and the Federal VA. Both organizations will inspect the new facilities prior to and/or upon opening.

The Home's construction at: reaches what is called "substantial

completion" when MDVA assumes ownership of the property. Substantial completion is expected by mid-November for Preston and late November for Montevideo and Bemidji.

At this time, we expect that Resident admissions could begin in mid-December for Preston and mid-January for Bemidji and Montevideo.

Once the Certificate Occupancy is obtained, informal tours/open houses will be offered to small groups of community stakeholders and future Residents and their families.

A formal Grand Opening/ Dedication Event is expected in spring 2024 to allow for warmer weather.

The Post Commander will need to notify the VFW Membership Department in May or June of any Auxiliary members who recruited VFW members and the number recruited.

Per the voting of the Delegates at the 2023 National Convention:

- Department Secretaries may now update changes in the Treasurers position in MALTA. The requests to change the Treasurer no longer need to be sent into the VFW Auxiliary National Headquarters
- The Office formerly known as Conductors/Conductor will only be known as Conductor.
- unbecoming Conduct member in their relations to the VFW Auxiliary or the VFW organization or any member(s) thereof is now a part of the National Bylaws. National says quite simply "Be kind & polite or be quite."

The new MALTA Bookkeeping Application is now available. You will find the link on your MALTA Dashboard – all the way to the righthand side of the shortcuts at the top of your DUTIES page. Auxiliaries are NOT REQUIRED to use this application; it was developed to make the Treasurer's job easier. The system developed specifically for the VFW Auxiliary is similar to QuickBooks and is quite user friendly. It will make reporting easier each month and will

assist in giving your Trustees some of the information they need for their quarterly audits. There is a USER GUIDE available in MALTA. This application is only available to the Treasurer.

National still requests two (2) dollars per member for the Cancer Grant Program to keep it viable. This is NOT a requirement; an auxiliary can give as it wishes. The last balance given for that account at the National Council Meeting was in excess of Sixty (60) Million dollars. FYI.

The VFW Auxiliary has twelve (12) programs to participate in. It IS NOT required to participate in all of them. ## **Claims and Service Office Report**

## VA Covers Cost of Parkinson's for Families of Lejeune Veterans

November 10, 2023

WASHINGTON — Today, VA announced that family members of Veterans exposed to contaminated drinking water at Marine Corps Base Camp Lejeune from Aug. 1, 1953 to Dec. 31, 1987 are now eligible for reimbursement of health care costs associated with Parkinson's disease under the Camp Lejeune Family Member Program.

These family members are also eligible for health care reimbursement for esophageal cancer, lung cancer, breast cancer, bladder cancer, kidney cancer, leukemia, multiple myeloma, renal toxicity, miscarriage, hepatic steatosis, female infertility, myelodysplastic syndromes, scleroderma, neurobehavioral effects, and non-Hodgkin's lymphoma.

"Veterans and their families deserve no-cost health care for the conditions they developed due to the contaminated water at Camp Lejeune," said VA's Under Secretary for Health Dr. Shereef Elnahal, M.D.

"We're proud to add Parkinson's to the list of conditions that are covered for Veteran family members, and we implore anyone who may be living with this disease — or any of the other conditions covered by VA's Camp Lejeune Family Member Program to apply for assistance today."

Veterans who served at Camp Lejeune are also eligible for no-cost Parkinson's health care and other VA benefits. Recent studies have also shown that the risk of Parkinson's disease is 70% higher for Veterans stationed at Camp Lejeune.

Thanks to the PACT Act, the biggest expansion of Veteran health care and benefits in generations, Veterans and their families can also now file lawsuits for harm caused by exposure to contaminated water at Camp Lejeune. # All WWII Vets Eligible for FREE Health Care & Nursing Home Services

November 10, 2023

WASHINGTON — Today, the Department of Veterans Affairs announced that all World War II Veterans are now eligible for no-cost VA health care, medical services, and nursing home care.

All WWII Veterans who served between Dec. 7, 1941, and Dec. 31, 1946, are eligible under this expansion, regardless of their length of service or financial status. These Veterans will not have to pay copays, enrollment fees or monthly premiums.

VA is reaching out by phone and mail to encourage WWII Veterans who are not currently enrolled in VA care to apply today. Veterans who enroll may also keep their private providers, Medicare, and most other insurance to meet their health care needs.

"These members of Greatest Generation answered the call to serve when our nation – and the world – needed them most. Now, it's our job to serve them in every way that we can," said VA Under Secretary for Health, Dr. Shereef Elnahal. "We are proud to provide world-class, no-cost health care to these heroes at

VA, and we encourage all of them to enroll today."

All WWII Veterans are encouraged to enroll in VA health care — the best, most-affordable health care in America for Veterans. Veterans who are enrolled in VA health care are proven to have better health outcomes than non-enrolled Veterans, and VA hospitals have dramatically outperformed non-VA hospitals in overall quality ratings and patient satisfaction ratings.

Veterans who were not approved for VA health care in the past due to income limits should apply again; income levels no longer apply due to this expansion. VA cannot automatically enroll these Veterans in health care; WWII Veterans must apply for VA health care if they are not currently enrolled.

This expansion is made possible through the Joseph Maxwell Cleland and Robert Joseph Dole Memorial Veterans Benefits and Health Care Improvement Act of 2022 (Cleland-Dole Act), signed in December 2022. ## New Survey Lists top Challenges When Transitioning Out

November 9, 2023

GEORGETOWN, Texas — It takes seven months for veterans to feel they've adapted to civilian life after active duty, new research suggests.

A new survey of 1,000 U.S. military veterans revealed there are an average of three different major challenges on this journey.

Finding a job topped the list, with a third (33%) of respondents calling it their biggest hurdle. Other challenges included parting ways with their friends in the military and finding a purposeful career (28% each).

Conducted by OnePoll on behalf of Sport Clips Haircuts for its VFW's "Sport Clips Help A Hero Scholarship" program, the survey also found that six in 10 (60%) veterans already had long-term goals in mind after leaving the military.

These goals included finding a purposeful civilian job (56%), homeownership (52%), and getting married and having children (46%).

"From serving their country to serving their communities, veterans bring an array of transferable skills to their civilian careers," said Gordon Logan, founder and chairman of Sport Clips, and Air Force veteran. "While a meaningful job and career were a top goal for many, they may not have always been aware of all the resources available to help support them in their journey. It's important to ensure the next generation of veterans knows about support programs and other services offered by veterans' organizations such as the VFW."

Some also noted milestones they had yet to experience when they left the military, such as pursuing higher education or a college degree (27%).

One in five (20%) revealed they had never created a resume at that point in time.

While the military taught many transferable skills, such as the ability to perform under pressure (50%), teamwork and collaboration (41%)

and problem-solving (39%), it took an average of four months for veterans to find a civilian job.

To help boost their self-confidence during the adjustment to civilian life, a third of veterans (33%) took classes or continued their education.

Twenty-nine percent also credit their partner or spouse with helping them transition after their service.

Additionally, veterans shared their biggest tips in transitioning to civilian life, including taking your time to get adjusted, keeping a daily routine, starting to save your money before leaving the military, and continuing your education.

"One in five veterans polled said a lack of funds prevented them from pursuing their educational goals," Logan added. "Whether they're a first-time college student or continuing their education, the Help A Hero scholarship program gives service members and veterans can get the assistance they need to further their studies without incurring excessive debt."

To speed up your meetings, our parliamentary authority, Robert's Rules of Order New Revised (12th edition), calls for a quick, streamlined approach where no motion for approval is needed.

Chair: "The Secretary (Adjutant) will read the minutes." Or, "The minutes have been distributed in advance."]

The Secretary reads the minutes if not distributed in advance.

Chair: "Are there any corrections to

the minutes?" [Pause] Chair: "Hearing no corrections, the minutes are approved."

The chair moves on to the next item of business.

Or, if there are corrections:

Member states a desired correction. Chair: "If there is no objection the

correction will be made."

[Pause]

Chair: "Hearing no objection,

the correction will be made. Are there any other corrections to the minutes?" [Pause]

Char: "Hearing no further corrections, the minutes are approved as corrected."

The chair moves on to the next item of business.

In the unlikely case that there is an objection to a proposed correction, members may debate the correction and adopt the correction with a majority vote.

#### **VFW State Legislative** Report

By Kevin L. Shepherd, State Legislative Chairperson

Hello Comrades, I hope you all had a wonderful Thanksgiving. From a legislative view for veterans in our State I'd like to share the items that are on the Commanders Task Force's list of priorities for 2024.

There were a group of items that were to be discussed and reviewed during the Commanders Task Force meeting on 14 November.

- 1. We are hopeful that the legislature will continue the two year trend in to 2024 and approve a "clean" Veterans Omnibus Bill. This means that we would like to have all the Veterans topics that are brought forward to be kept separate from other bills. This keeps the bill veteran focused and doesn't muddy the water with other topics distracting from our veteran's needs.
- We are working to make an adjustment to the property tax exclusions, we'll be approaching the legislature to change the first exclusion to veterans rated 50 to 100 percent disabled at \$200,000 off their property tax value and then provide a market value exclusion of \$400,000

- for 100 percent-rated veterans. We would also like to see these 6. Our Post Homes are under values be inflation based and remove the "equal to or lesser value" language for surviving spouses.
- There is a plan to request an alteration to MN Statute 197.63 to include County Veteran Service Officers in the list of "vital records."
- We are planning on asking the MN Department of Natural Resources to waive license fees for all veterans for hunting, trapping and fishing.
- 5. Gold Star families will garner more support this coming year as well. There will be requests to a change to MS 273.13, Subd. 34(d). It currently reads that the surviving spouse of a fallen soldier must file for property-tax exemptions and have lived in the dwelling when their service member passed away. This excludes any Minnesotans who are living elsewhere because Active Component/Duty stationing from applying for this

- property tax exemption.
- pressure by property taxes as well. We will once again request that our organizations, 501(c)(3)s and 19s be given the same tax treatment as our Churches and the YMCA, 501(c)(3)s.

A few more things we'd like to personnel authorized to receive begin movement on are the funds collected through military and veterans license plates. Currently only the "Support our Troops" plates go into a fund managed by the Minnesota Department of Veterans Affairs (MDVA). We'd like to see the funds from the other 40 types of veterans plates flow to the MDVA. We are asking to add a few more types of plates as well – these include Jewish War Veterans, and retiree plates for all 6 branches of service.

I hope to see many of you on Wednesday, April 10th, for Veterans Day on the Hill 2024! This is when we gather together to speak with, encourage and thank our legislature for working with us to make Minnesota a more Veteran friendly place to live.

## VFW Ramps up Efforts to Combat Claim Sharks

Predatory Claim Shark companies are engaging in illegal activities and there is no gray area here, no matter how much money they want to throw at it

VFW National Commander Duane Sarmiento:

For more than a century, your VFW has been on the forefront of advocating for veterans and their earned benefits. In the last year alone, more than 550,000 veterans received more than \$13 billion in benefits from VA through the diligence and professionalism of the VFW's global network of VA-accredited service officers. Not a penny of this \$13 billion went to line the pockets of the VFW. It all went to the veterans, as the law requires.

The VFW has been a vocal opponent of predatory "Claim Sharks" – companies who charge veterans illegal fees for sub-par VA benefit claims assistance. Make no mistake, the proliferation of these illicit organizations is a threat, not only to the VFW's cornerstone National Veterans Service (NVS) program, but an even greater threat to the VA benefits system as we know it.

Since their emergence, the VFW has ratcheted up the pressure on these companies by passing legislation to crack down on their practices at the state level and are working to help veterans bring litigation against them. We have trained our more than 2,300 VFW Accredited Service Officers on how to handle Claim Sharks, and we continue to seek out veterans who need help getting out of

these predatory contracts.

Now these Claim Sharks are trying to normalize and legitimize their financial exploitation of our nation's disabled veterans — they even named VSOs like the VFW as their "threats." While we should be flattered that they recognize the threat we pose, now is the time to decisively defeat this scourge.

The Bottom line is: Predatory Claim Shark companies are engaging in illegal activities. There is no gray area here, no matter how much money they want to throw at it. Their latest collusion is a desperate attempt to avoid accountability.

Your VFW has aggressively pursued this issue in all corners of government, solidifying the veteran community's stance on this issue. You will see more from the VFW in the coming weeks, asking you to take action with your Congressional representatives, your legislatures and your communities. We encourage you to read up on the facts and familiarize yourself with this issue, and to help we have produced a VFW Claim Shark Fact Sheet for you to use and distribute widely to veterans. Like the VFW said last year before Congress, "Any group that fails to adhere to VA's well-established standards of accreditation and fee arrangements should be greeted at the door by Capitol Police, not offered a seat at the same table as VA-accredited representatives who are held to certain professional and ethical standards."

## Frank Wilkins Still Going Strong at 99


WWII veteran Frank Wilkins, born July 5, 1924 has lived on his own ever since the passing of his wife in 2010.

Born in Minneapolis but raised in Mankato, he enlisted in the US Army February 16, 1943. After the standard basic training, the Army knew what was best for Frank and where he was needed the most. He became a combat rifleman.

Then Frank was off to see the world as part of the 45th Infantry (Thunderbird) Division.

Frank and the 45th were deployed in late June, 1943 to North Africa for additional training. One month later, they all landed in Sicily by way of an amphibious assault. There they met some stiff resistance. September 10 it was off to Salerno, Italy. They fought their way to just north of Cassino before being pulled out to prepare for a beach assault at Anzio, Italy on January 22, 1944.

There, Frank recalled hearing the incoming shells from German railroad guns ("Anzio Annie" and "Anzio Express"). The big guns were targeting supply dumps and hospitals on the beach and supply ships in



the harbor. He remembered a B-25 bomber flying 25 feet off the deck right over the them to drop bombs on the advancing Germans.

While at Anzio, Frank along with others was hit by a stray shell. He walked to the hospital to get patched up and was sent on to Naples to recover. Later, he rejoined the 45th as they fought their way thru Italy before being withdrawn for yet another assault landing in southern France, August, 1944. Then up through western France to the

German border by the end of the year. In March 1945, the 45th crossed the Rhine River and headed southward towards Homburg, Nuremberg and Munich before stopping near Dachau when the war ended.

Frank was discharged December 4, 1945. He enrolled in Mankato State under the GI Bill. It was there that he met his sweetheart Phyllis. A year after they both graduated, they got engaged and were married in Worthington June 17, 1950. They moved to Mankato and finally settled in Willmar. They had four lovely children.

Frank had a successful career in banking and retired at age 65. He has stayed busy with building model railroads, ship models, wood carving and shop projects made of wood for gifts to his children and friends. He still lives independently at home in Willmar.

He has remained an active member of VFW Post 1639, Masons, and the American Legion.

Every Saturday after church, he drives his car to Willmar VFW Post 1639 to visit friends and pickup chicken wings for supper.

## **Bus Depot Door Lives On**

An important part of downtown Grand Rapids was the Redding Bus Depot. Built February, 1941, the original building housed Redding's Cafe and the Bus Depot with the Miller Bowling Center in the basement.

The Bus Depot was the transportation hub of the community as Greyhound buses carried residents to locations throughout Minnesota. It finally closed its doors in 2021 when several buildings were removed to make way for the expansion of the Itasca County Justice Center.

It was during the Vietnam days in the 60's and 70's that many young men and women walked through the Bus Depot door as the were drafted or volunteered to serve their country. Residents and military personnel continued to use this door as recently as the mid-90's.

When it came time for the building to be torn down, Vietnam veteran Kenny Clafton sprang into action with the idea of saving and preserving the very door that so many of his fellow veterans walked through. With the help of the County Veteran Service Officer, the Itasca County Commissioners approved donating the door to the Itasca County Historical Society. The next issue was to find a "home" for the door.

It was agreed that best place to display the door would be at VFW Post 1720 in Grand Rapids.

The old Bus Depot Door had found a "home" at last.

I want to wish everyone of my comrades a safe and happy holidays, a Merry Christmas and a happy New Year Guaranty Service (LGY) helps address the needs of Native American Veterans through the Native American Direct Loan (NADL) program, a special initiative that supports Native American Veterans who want to buy, build or refinance a home on federal trust land.

Created in 1992, NADL has steadily grown, opening the doors for more Native American Veterans to own homes. Some of the benefits Native American buyers receive through the NADL program include not having to provide down payments or secure private mortgage insurance, in addition to paying limited closing costs and receiving low interest rate loans

For Native American Veterans to apply to NADL, their tribe must have a Memorandum of Understanding (MOU) with VA. LGY has worked closely with tribal leaders to sign 111 MOUs.

The NADL team embarks on a vigorous engagement schedule each year, visiting as many tribal communities as possible, either inperson or virtually, to raise awareness on NADL benefits, and to help draft MOUs with tribal nations not yet participating in the program.

**68 Year VFW Tradition Continues**

During the 2023 VFW State Fall Conference in Rochester and at the 'eleventh hour', Alexandria VFW Post 936 placed a bid for the 2024 VFW State Invitational Bantam Hockey Tournament. The bid was approved by the State Youth Activity Committee and the State Council of Administration. The dates of the VFW State Invitational Bantam Tournament are February 9 - 11, 2024 in Alexandria.

The 'standing' bid from Elk River – Rogers VFW Post 5518 for the 2024 VFW State Invitational U15A Girls Hockey Tournament was also approved. The dates of the VFW U15A Girls Tournament are March 8 − 10, 2024 in Elk River.

Due unbelievable to an Minnesota Hockey Schedule and a growing number of various Hockey Association Tournaments, it has become 'very difficult' for the Veterans of Foreign Wars to fit our VFW Hockey Tournament Program into this 'very' tight schedule! With a lot of due diligence and some hard work, the VFW State Youth Activity Committee is keeping the VFW Hockey Program alive (but struggling).

The VFW also has to contend with the growing cost of Hockey in Minnesota. The average sixteen team Hockey Tournament is running between \$35,000 to \$45,000 (this includes a Team Banquet). To help defray most of the 'out-of-pocket' expenses for the host VFW post, the VFW State Youth Activity Committee and the State Council of Administration also passed a \$2,000 VFW Post Sponsorship Fee per



participating team. Although this may be a hardship to some posts, it does help in finding a host post for the Tournaments. Thankfully, our posts have charitable gambling and need to put their funds back into the community. Although, difficult for some, it is beneficial for the VFW Hockey Program.

To help some of our sponsoring posts, we have put out the word to non-sponsoring posts. We have asked them to 'team-up' with neighboring VFW posts in the area for possible co-sponsorships. Hopefully, effort will keep the VFW Hockey Program alive in Minnesota.

Currently, both VFW Invitational Tournaments are filling up with 'dedicated' hockey teams and they are all looking forward to what the VFW Hockey Program has to offer them.

After receiving his stateside training, he received orders to join the 2nd Infantry Division Artillery in South Korea. John served as an Operations and Intelligence Specialist. While there, he was promoted to sergeant. He served a harrowing year right on the DMZ during the U.S.S. Pueblo Incident. To say that tensions along the DMZ were high is an understatement.

John was happy when his tour was up and he received his DD-214. It wasn't until he inquired about VA health care that he discovered there was no mention of his year spent in Korea along the DMZ.

It was during the 60's that Agent Orange was being used as a defoliant

in Korea. All veterans who served in Korea along the DMZ are eligible for Agent Orange benefits.

When the Palmer Lake Post heard about John's situation, they sprang into action and worked with the County Veterans Service Officer to get John a DD-215 which amended the original DD-214.

With that completed, the Army sent the overseas service and campaign medals he so rightly deserved.




