LOUISVILLE, KY -- Dr. James R. Tuorila (Department of Minnesota) was elected National Surgeon General of the Veterans of Foreign Wars of the U.S. on Aug. 1, 2024, at the 125th VFW National Convention in Louisville, Kentucky.

James served in the United States Army from 1973 to 1977, earning his VFW eligibility by serving in Korea. In recognition of his service, he received the National Defense Service Medal, Good Conduct Medal, Korean Defense Service Medal, and two Army Commendation Medals.

He joined the VFW in 1995 at Post 428 in St. Cloud, Minnesota, where he maintains his Gold Legacy Life membership. James has served as Post Commander, All-American District Commander and Department Surgeon. This is his fourth time serving as National Surgeon General.

James received his Bachelor of Arts degree from Bemidji State University in 1979, his Master of Arts degree from Wichita State University in 1981, and his Ph.D. from Texas Tech University in 1986. He retired from the St. Cloud VA Medical Center in St. Cloud, Minnesota, and



LOUISVILLE, KY -- Alfred "Al" Lipphardt, a Georgia native and veteran of the Vietnam War, was elected today as the new national commander of the Veterans of Foreign Wars (VFW), a congressionally chartered veterans service organization comprised of more than 1.4 million eligible veterans and military service members from all six branches of the armed forces. Lipphardt's assumption of command took place during the VFW's 125th chief to those attending in person at the Kentucky International Convention Center and watching via livestreaming video, at the conclusion of the weeklong gathering. Approximately 10,000 members of the VFW and its Auxiliary converged on the city to conduct the business of the organization, recognize individuals and organizations for excellence and to elect new leadership for the 2024–2025 year. It is a great time to be a VFW Auxiliary Member in Minnesota!

The National VFW "Ladies" Auxiliary was established in 1914, and on January 23,1925, the Veterans of Foreign Wars "Ladies" Auxiliary in Minnesota began with the granting of the Department Charter with the foundation of 13 local Auxiliaries. Florence Hiland served as our first Auxiliary President in 1925-1926. The term "Ladies" was removed from the original name in 2015 when membership in the VFW Auxiliary was expanded to include male spouses and family members of eligible members. Today, Minnesota 18,000 members nearly has representing 117 auxiliaries.

January 7, 2025, also serves another 100-year milestone as celebration of the beginning of our VFW National Home. It began with the vision of a 23 year old woman named Amy Ross who was working to find jobs for thousands of unemployed veterans in Detroit, Michigan in 1922. Her efforts were recognized by a millionaire who donated 472 acres of land near Eaton Rapids, Michigan, and the VFW National Home was born. In the spring of 1925, the first family moved in, comprised of a military widow and her six children.

Over the past almost 100 years, the National Home has expanded and continued to serve the changing to this great country and fighting for needs of military veterans and their families. If you have not visited,

VFW Recommends TAP Class Reform

In a March House VA Subcommittee on Economic Opportunity hearing, VFW offered insight into the military's Transition Assistance Program (TAP) and addressed a proposal aimed at enhancing the process.

VFW National Legislative Deputy Director Kristina Keenan highlighted several critical aspects of TAP-related legislation. Keenan said VFW supports provisions that will improve transition services for troops leaving the military. She added that it is important to include accredited claims representatives, such as VFW service officers, in the TAP process.

"This would enable service members to have a point of contact to begin their pre-separation claim," Keenan said. "We also support the bill's inclusion of pre-enrollment in VA medical care during transition. This would provide veterans with their earned benefits the day they leave the military."

Keenan told Congress that VFW works with about 10 percent of the troops who attend TAP sessions.

"We strongly believe there needs to be accountability for [the Department of Defense] to follow the law," Keenan said. "Commanders should be held responsible for ensuring their transitioning service members attend TAP in a timely

manner."

Furthermore, Keenan expressed VFW's support for the proposed legislation's inclusion of preenrollment in VA medical care during transition. This provision would enable veterans to access their entitled benefits immediately upon leaving the military, facilitating a smoother transition into civilian life, she said.

"This draft bill also includes reports that would ensure regular updates on critical aspects of transition, such as timeliness, attendance, pathway participation and frequency of participation," Keenan testified. "The VFW has spoken about the elements in this proposed legislation during numerous hearings before this subcommittee and before the Senate."

In her testimony, Keenan underscored the VFW's commitment to advocating for legislation that enhances veterans' well-being and ensures they receive the support they deserve. The VFW's endorsement of these proposals reflects a broader effort to address the evolving needs of veterans and improve their overall transition experience.

"We hope this subcommittee engages with us to help refine this proposal to ensure it provides the great resources it intends," Keenan said.

Vet Crisis Line Supports More Vets Than Ever

July 16, 2024

WASHINGTON — Two years ago, the launch of Dial 988 then Press 1 made it easier than ever for Veterans and their loved ones to access lifesaving support via the U.S. Department of Veterans Affairs' Veterans Crisis Line. In these past two years, VCL has answered more than 1,638,138 calls, representing a 22.7% increase in calls per day since the launch. This means that more Veterans than ever are getting the support they need from caring, qualified responders during times of crisis. Dial 988 then Press 1 provides an easy-to-remember number to quickly connect Veterans, service members, and their loved ones to the Veterans Crisis Line's lifesaving services. Since the launch of the shortened number, VCL has maintained an average speed to answer of 9.17 seconds. In addition to the increase

in calls answered, VCL has also received a 76.7% increase in texts and 27.5% increase in chats per day over the same two years.

"Our Veterans Crisis Line has been providing Veteran-centered support for nearly two decades, and two years ago we made it even easier for Veterans in crisis and their loved ones to reach out for help by launching Dial 988 then Press 1," said VA Secretary Denis McDonough. "One Veteran lost to suicide is one too many. We're supporting more Veterans than ever through the 988 initiative and will not rest in our continued efforts to spread the word that this resource is available and saves lives."

VA Providing more care and Benefits to Women Veterans than Ever

June 12, 2024

WASHINGTON — Today, on Women Veterans Recognition Day, the U.S. Department of Veterans Affairs announced that more than 53,000 women Veterans enrolled in VA health care between May 2023 and May 2024, marking a 20% increase over the previous year and the largest enrollment year for women Veterans on record.

Health care enrollment of women Veterans increased across all 50 states, with the greatest number of enrollments in: Texas (6,507), Florida (4,666), California (4,318), Virginia (3,806), Georgia (2,937) and North Carolina (2,776). Women Veterans are currently VA's fastest growing patient population. This historic enrollment of women Veterans into VA health care and benefits is driven in large part by the PACT Act, which President Biden signed into law in August 2022, empowering VA to deliver record health care and benefits to millions of Veterans exposed to toxins while serving in the military.

Expanding access to benefits and services for women Veterans is a key priority for VA and the entire Biden-Harris administration. This is critical because Veterans who come to VA are proven to do better. VA health care has consistently outperformed non-VA care in Veteran trust, patient satisfaction scores, overall quality ratings, and affordability.

"On this day in 1948, women were granted a formal place in our country's military. Today, the more than 2 million women Veterans living in the U.S. make up our fastest growing Veteran population," said VA Deputy Secretary Tanya Bradsher. "It's important to all of us here at VA that every woman Veteran knows she belongs at VA."

"It's our goal for every woman Veteran to receive all the benefits she has earned, and that includes worldclass health care," said VA Under Secretary for Health Shereef Elnahal, M.D. "We want women Veterans to know that VA has invested in more services for women Veterans than ever before. VA can now offer women the best and most accessible options for all their care needs, and we want them to apply for the health care they deserve today."

VA is leading the way in specialized health care for women Veterans. VHA's Office of Women's Health oversees these dedicated health care services. Today, there is a women's health program led by a Women Veterans Program Manager at every VA health care system across the nation. Additional specialized women's health staff include: Women's Health Medical Directors, Women's Health Primary Care Providers, Women's Health Patient Aligned Care Teams, Maternity Care Coordinators, Breast and Cervical Cancer Screening Coordinators, and Women's Mental Health Champions. Women's health teams are also supported by LGBTQ+ Veteran Care Coordinators, Intimate Partner Violence Coordinators, and Military Sexual Trauma Coordinators.

Over the past two years, VA has dramatically expanded health care services dedicated to women Veterans. This includes expanded breast cancer screenings and mammograms for Veterans with potential toxic exposures, increased access to reproductive health services, and expanded maternity care coordination for Veterans from pregnancy through 12 months postpartum. All of this work contributes to VA's equity action plan and broader efforts to ensure that every Veteran gets the care and benefits they deserve.

VA is also delivering disability compensation benefits to an all-time record number of women Veterans, with 717,141 women Veterans receiving disability compensation benefits today. Over the past five years, an additional 197,667 women Veterans have begun receiving benefits, representing a 28% increase. More than 89% of women Veterans who have applied have received disability benefits from VA for at least one condition, on average receiving \$27,109 in earned disability compensation benefits per year.

Today, more than 1,000 responders — many of whom are Veterans themselves — ensure that every Veteran has somebody to call for support in time of crisis.

Message <u>From Your</u> National Council Member

Our 2024-25 year is well underway with leaders at all levels having been elected, installed and carrying out the business of the Veterans of Foreign Wars. I congratulate all those recognized with All-State and All-American honors – challenging to attain and reflect utmost credit on your post, your district and the Department of Minnesota.

One of the most significant accomplishments in the history of the VFW was the passage into law of the Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act, better known as the PACT Act. The Act was signed by President Biden on August 10, 2022, and initially named 23 specific conditions for which veterans and their families will not need to prove service connection to obtain medical treatment and/or disability compensation as a result of toxic exposures so many suffered.

The list of presumptive conditions continues to grow and includes coverage for Vietnam era veterans as well. Signing the bill was only the first step as the Veterans Administration became responsible for informing veterans and their families of their eligibility for benefits and services, for processing the claims of those affected by toxic exposure, and for training VA and non-VA health care providers to assess the effects of environmental exposures.

On March 5, 2024, the VA expanded health care to millions of veterans – years earlier than required by the PACT Act. This is the work the VFW tirelessly does daily and must be part of the message we deliver to veterans eligible for membership in the VFW as we work to recruit, reinstate and retain. If a veteran asks, "What's in it for me?", share the fact that benefits delivered by the VA are often as the result of the relentless efforts by the federally chartered veteran service organizations to ensure the veteran community and their families are cared for compassionately to the highest professional standard. 

Programs are also vital to the VFW. They are truly necessary and a great way to recognize our fantastic students, teachers, firefighters and police of each community, just to mention a few.





Our next meeting will be in Wilmont on October 5th.








Greetings from the 6th District!



his vision for the year, which he deems "Operation All In," calling on all levels of the organization to embrace courage and the warrior spirit that sets the VFW apart as the oldest and largest combat veterans organization.

"Veterans of Foreign Wars Posts are some of the very few places where heroes gather, and warriors meet," said Lipphardt. "Too many people in this nation have forgotten what it is to be a warrior. Heroes are what others think of us. Warriors are who we are."

Throughout Lipphardt's speech, he reflected on those he served with in the Army, veterans within his family, and how they influenced his life. A solemn moment came when he spoke the names of the ones he lost during the Vietnam War.

Lipphardt's remarks harkened back to core tenants of the VFW, as well as its stated vision – ensure that veterans are respected for their service, always receive their earned entitlements, and are recognized for the sacrifices they and their loved ones have made on behalf of this great country.

"I have only been a member of the Veterans of Foreign Wars for 20 years, but I have seen too many members who have forgotten our roots," said Lipphardt. "Whatever the branch, whatever the military specialty, or whenever the conflict, let us never forget those who no

longer have a voice."

Lipphardt joined the VFW in 2002 when he became a charter member of VFW Post 12002 in North Fulton, Georgia. He later transferred his Gold Legacy Life membership to his current post VFW Post 2667 in Newnan, Georgia. He has served in elected and appointed positions at the Post, District and Department levels, culminating with his election as the VFW Department of Georgia commander from 2014 to 2015. On the national level, he has served the Legislative Committee, on the National Security and Foreign Affairs Committee, and the Council of Administration.

Much of Lipphardt's remarks after being installed as commanderin-chief emphasized a commitment to values and valuing service to the nation. He also spoke about the importance of integrity within the organization.

"If your word is not to be trusted, everything and anything you do is unreliable. You can't be called on nor can you be counted on," said Lipphardt. "There is no place in the Veterans of Foreign Wars for these individuals."

"My ask is for you to embrace the vision of courage," said Lipphardt. "Rekindle the warrior's fire in your belly. Put that vision into action. I am proud to lead you, as together, we seek the courage to be the best we can be in all things and at all times."

"Believe in what you do -Do what you believe in."

at 11 different rural cemeteries. This nearly 90-mile route is covered every Memorial Day.

While conducting these services, it became apparent that many of these small communities could benefit from a means of recognizing the veterans interred there. John Olstad, Post Adjutant, suggested that the post provide each of the cemeteries with not only a map and roster, but the means to display them. The post does not own a post home/canteen but rents space from the Cotton Community Center for most of their meetings and events. This effort then would have to be funded out of the posts limited coffers.

Gretchen Larsen, Post QM and District 8 Adjutant suggested asking the MN VFW Charitable Association for some help. Post 3044 received a \$2200 grant with the remaining funds coming from post funds to provide each cemetery with a weatherproof enclosure. John Olstad assembled an information packet to accompany each display, which included a roster of buried veterans, a cemetery grave map, information on flag display, grave marker ordering, and contact information for the Post as well as the County Veterans Service Office. Now, all who visit the cemeteries



Civil War Soldier Finally Receives Headstone

Sgt. John Wesley Harper has lain in an unmarked grave at Crystal Lake Cemetery in Minneapolis since his internment on May 6, 1920.

He was born April 26, 1839 in Wheeling, West Virginia.

On May 5, 1863 at the age of 23, Harper joined K Company, 54th Massachusetts Infantry Regiment. Massachusetts was the first state to form a Black voluntary infantry unit. Harper was the company bugler.

The 54th is the subject of the movie *Glory* (1989) starring Morgan Freeman. It immortalized the unit and their attack on Fort Wagner, South Carolina on July 18, 1863.

Harper was wounded during this battle and carried the bullet to his grave.

He was mustered out after the



Civil War. Harper reinlisted and continued to serve as a member of the 25th US Infantry (Buffalo Soldiers) garrisoned at Ft. Snelling for nearly thirty years. He retired from there as an ordinance sergeant.

In early 1904, the *Minneapolis Journal* contained interviews with Twin Cities residents who were survivors of the 54th Massachusetts Infantry. At that time, Harper stated

Timely Tidbits

From Farmer to Seabee to Salesman to VFW Vet

Born July 29, 1926, Kenneth W. Langmade would eventually be the second of eleven children. When the Great Depression started in 1929, his parents moved the family from Minneapolis to a couple of rented farms first in St. Francis and then Crown, MN over the next few years. Finally, as the family grew larger, like farm families always did, they settled down in the Elk River area.

It was in 1944 during his senior year that a navy recruiter came to visit the Elk River High School. Ken decided that he needed to go defend his country. The day after graduation, he was shipped off for basic training at Farragut Naval Training Station in northern Idaho. He was one of nearly 300,000 young seamen trained there over a four-year period.

Ken decided that he wanted to be a Seabee. So, he was sent to San Francisco where he became a heavy equipment mechanic and operator and then on to Pearl Harbor to help rebuild the naval base buildings after the Japanese attack.

After stops at Midway and Wake Islands Ken arrived on Guam where he spent 18 months rebuilding the airstrips. The Seabees were pushing back the jungle as they widened the airstrip to handle the larger land based bombers. Marine units were assigned to protect them from snipers who hid in the trees. Ken supervised and became friendly with several Japanese POWs who worked as laborers. One of his memorable souvenirs is a hand-painted handkerchief given to him by one of the POWs.

Ken recalled one particular occasion when nature called and he had to get off the dozer. As he approached the edge of the jungle, he smelt an odd odor. A marine squad was sent to investigate and found a hut with 3 Japanese soldiers and 3 Philippine women 100 yards into the jungle.

While on Guam, Ken was selected along with other Seabees was for specialized amphibious assault training. They were to accompany Marine units as they prepared for a land invasion of mainland Japan. They were waiting offshore when the atomic bombs were dropped.

March, 1946, Ken was discharged from the Navy on Okinawa and sent home to the family farm near Elk River.

He then bought a small farm near Crown, MN. After several years, he gave the farm to his parents, moved to Minneapolis and then off to Chicago where he earned a degree in electrical engineering thanks to the GI Bill. With the help of additional training in TV repair, he opened a small TV repair shop in Minneapolis and married Janette. The shop burnt down when a fire in an adjoining building spread to his shop.

After the fire, Ken tried to get financial help from his parts supplier. Instead, he was offered a job as a parts salesman. He parlayed that into a lifetime career ending as the top regional salesman in the MN, Western WI and Northern Iowa area for GE and Sylvania electronic parts. He retired in 1971.

The family (2 boys and 2 girls) lived in Blaine for 50 years. Ken found time to join Kraus-Hartig VFW Post 6587 in Spring Lake Park as a life member. He served as the post quartermaster and both district and department inspector for many years.

Ken and Janette remained very active in post and auxiliary functions until they moved to East Bethel in 2010.

They currently reside together in the Arbor Oaks Senior Living facility.

that even though he was born in freedom, the idea of an all-black regiment really interested him.

Harper raised a family of 16 children and spent his remaining years in Minneapolis until his death on May 2, 1920.

It was while working on creating a database for the <u>Sons of Union</u> Veterans of the Civil War that MN VFW member Gary Carlberg met Harry Davis Jr. great-great-grandson of John W. Harper.

Carlberg informed Davis of a project called Operation Headstone

whereby a proper military headstone would be placed on Harper's grave site to honor his years of service to his country.

On June 23, 2024 many of Harper's descendents gathered along with other dignitaries including MN VFW Cmdr. David Staehlin, the Honor Guard from Palmer Lake VFW Post 3915, 1st Minnesota Infantry and many others to dedicate a proper military headstone.

After 104 years in an unmarked grace, Sgt. John W. Harper would receive the honor that he so long ago deserved.


