VFW Nat’l Manual of Procedure, Section 803

Alternative Cap

Comrades,

At the request and direction of Commander-in-Chief Whitmore, I’m sending this to all Department Commanders to clarify a recent change to Section 803 of the National Manual of Procedure, adopted by the National Convention.

A new paragraph titled “Alternative Cap” now allows members, other than officers, to wear a baseball-style cap during meetings of the Post and District.

Here’s a quick summary of what that means:

- The cap must be the official cap, sold through the VFW Store, with VFW initials, Post numerals, state, rank of office (if applicable), “Veterans of Foreign Wars,” and the Cross of Malta.
- Lettering must be gold, and the trim on the bill may be gold, green, red, or silver—matching the braid colors used for each level of the organization.
- This is an alternative, not a replacement, for the standard overseas cap.
- It cannot be worn at formal ceremonies, in business attire, or at any event where the regulation cap is prescribed.
- For Districts, “meetings” includes both regular business meetings and District conventions.

Frequently Asked Questions

Can officers wear the baseball-style cap?
No. Officers must continue to wear the regulation overseas cap when performing their duties or representing the organization in an official capacity.

Does this apply at Department or National meetings?
No. The alternative cap applies only to Post and District meetings, including District conventions.

Can the alternative cap be worn at a Post social event or casual gathering?
Yes, provided it’s an informal setting where uniform caps are not otherwise required. The alternative cap should not be worn if the event is ceremonial, public-facing, or requires business attire.

Am I required to have my Post number, Department, or position on the cap?
No. Members may purchase a plain black cap that features only the Cross of Malta on the front and uses the appropriate bill color for their level: gold for Post, green for District, red for Department, or silver for National, based on their position.

Can a Post or District design its own version or use a different color?
No. The design, lettering, and color requirements in Section 803 must be followed exactly. Any deviations would make the cap non-regulation.

Can both caps be worn interchangeably?
Members may choose to wear either the regulation overseas cap or the alternative cap during casual meetings at the Post or District level. The overseas cap remains the standard for all formal and official functions.

What about members who hold dual roles (for example, Post officer and District member)?
When acting in an officer capacity, at any level, the member must wear the regulation overseas cap. When attending as a general member, the alternative cap may be worn if appropriate for that setting.

Can life members, All-State, or All-American honorees wear the baseball-style cap with their color designations?
No. Those color distinctions apply only to the regulation overseas cap. The alternative cap must remain black with gold lettering.

They are available from the VFW Store starting December for a cost of \$40.

Thank you to all the posts and districts that have sponsored our conferences with ads for our books. The book looks great! Cheryl has done an amazing job helping posts with their ads and putting the book together. The color really makes the ads pop. I have had many members comment on how great it looks. If you haven't done an ad yet, please talk to your post about doing one for the State Convention, and for all three events next year. The same goes for the districts that have yet to sponsor an ad.

Midwinter marks the halfway point of the VFW year. I have enjoyed getting out of the office and visiting posts throughout the state. From Redwood Falls to Little Falls, and Duluth to Mankato it has been fun attending post meetings and hearing about all the great things our posts are doing. The community impact is extremely impressive. Please make sure that your post is reporting all your community service events and donations. Before the Dashboard Minnesota was always a top five state in community service. Now that everything is on the dashboard, we are around 20th place in community service. I don't believe that we are doing less, we are just not reporting it. Please report all community service on the Dashboard. When I am at the State Capitol or Washington DC, I need to be able to tell politicians how much of an impact the VFW has in their districts.

By now you should have a lot of green on your post dashboard. Quarterly community service reports will keep you green. You need to have done at least one report from

July-September, and one report from October-December, and so forth. But, once again, don't just do one report, report all your community service. Patriots Pen and Voice of Democracy need to be reported prior to January 31. I will reach out to every district to make sure that every post that advances students to the district competition gets credit on the dashboard. Please report how many students participated, how many advanced to the district, and how much money in prizes and other costs you had. Poppies should already be purchased, or please order soon. And membership should be tracking toward the goal of 101%. And don't stop at 101%. The higher you go on membership the more points you get toward All State, and you get more awards for All American if you finish in the top 15 of your division.

I am seeing a lot of problems with audits. Many posts do not show a balance in their Relief Fund. Maintaining a Relief Fund is required by the National Bylaws and must be reported on your quarterly audit. Your audit must also balance. The top portion is what your bank account balance shows. The reconciliation on the bottom is your checkbook balance plus outstanding checks. These two totals need to balance. Also, make sure you are reporting all your accounts on both top and bottom to balance the totals. You also need at least two trustees and the commander's signature on the audit. And please make sure you are properly bonded. Many posts are not bonded for nearly enough. Don't find out the hard way that you were under bonded.

At Fall Conference in September, information was presented on a possible Legacy Life Membership for Auxiliary members. Some feedback has come back to me but more information seems to be needed so I would like to share what I know with you.

The National VFW Auxiliary would like to provide Legacy Life Memberships similar to what the VFW currently offers. As your National District Council Member, I need some feedback to take to the National Council Meeting being held at the National Mid-Year Conference in February 2026.

Legacy Life Memberships would be a Life Membership that recognizes a members' significant investment in the VFW Auxiliary, and it would reward the Auxiliary of a Legacy Life Member for that investment.

There are 3 levels of Legacy Life Member available---Bronze, Silver, and Gold. The cost for each level would be \$400, \$800, and \$1200 respectively. A present member would purchase this and

their Auxiliary would then receive payments back for a period of twenty (20) years after their death. Payments would be \$6, \$12, and \$18 depending on the level purchased by the member originally.

You must be a Life Member of the VFW Auxiliary first before you can upgrade to a Legacy Life Membership.

Payment options and some personal items would be awarded to the member upon purchase, also. There are other details for this program to be considered and the National VFW Auxiliary continues to work on those.

Let me be your voice on the National level. I am honored to be your NDCM Area E representative from Minnesota.

New VFW Auxiliary Membership Application Coming Soon

1. Only the new VFW Auxiliary Membership / Transfer Application with the notation of "Revised - January 2026 in the bottom right corner will be accepted after January 1, 2026. All other applications should be thrown out or destroyed. If old applications are sent to the office, they will be returned to the local auxiliary.
2. ACH payments will no longer be accepted - it was felt if they could provide the voided check to do an ACH, they could just write the check to the VFW Auxiliary for processing.
3. No credit card information will appear on the Membership Application anymore. There will be a box to check if they are using a credit card. Once the Membership Application has been processed in MALTA by Department, a message (email or text) will be generated and sent to the person who is responsible for payment (credit card holder). This person will have thirty (30) days to respond to the request for payment. If their payment is not provided within that time limit, their application will be void.
4. During the time between the application being entered into MALTA and the credit card

payment clearing, the applicant will be a "Provisional" Member. Reports on these pending members will be available to Treasurers in MALTA so that you can track progress.

5. The Recruited by section also has been updated and eventually when the National VFW gets their new computer system up and running, we will be able to enter their VFW ID Member Numbers on our end because MALTA and the new VFW "Command Post" system (VFW MALTA) will be compatible.
6. There will also be the ability to upload a copy of the Membership Applications to the individual MALTA accounts for each member. These must be PDF files, and we will be able to go back and upload the applications of previous members, however, it will be vital that any credit card information is deleted. If this information is not deleted, fines can be incurred. Once the application has been uploaded to the individual members MALTA account that document will follow them the rest of their VFW Auxiliary life so they will have that information if they transfer, etc.

Why the VFW Provides Free Services

November 4, 2025

A government watchdog study in June revealed a high rate of potential mental health conditions among more than 50,500 troops surveyed upon exiting the military in 2023 and early 2024.

Published on June 5 by the Government Accountability Office (GAO), the report found that two-thirds of those troops might suffer from mental health conditions requiring follow-up.

"We know that military service is by nature dangerous and stressful," said VFW National Veterans Service (NVS) Director Michael Figlioli. "Exposure to stressors of all types often causes PTSD, depression or other related issues. That is the exact reason VFW provides essential free services linking these separating members with their VA benefits."

GAO, which also examined the VA's mental health screening for troops on their way out of the service between 2023 and early 2024, noted flaws in the manner in which service members were screened for PTSD and other mental health risks.

"Given concerns about the risk of suicide and other mental health challenges following service members' separation from military service, it is essential that they receive effective mental health screenings prior to separation," GAO officials wrote. "Such screenings can lead to the early identification of individuals potentially at high risk and help direct them to further assessment, treatment and intervention."

The concern stemmed from another troubling statistic noted in the report.

Of the troops who exhibited mental health risks, according to the study, more than half declined referrals to transitional programs run by the DOD, which offer counseling and other treatment opportunities to service members leaving the military.

For service officers at VFW, this conundrum is a two-fold problem requiring a solution.

"VFW knows statistically, separating service members are most at risk for suicide during the first year of leaving the military," Figlioli said. "That is why we stress the importance of working with these transitioning service members as early as possible. These critical benefits provide the safety net of income, housing, employment assistance and health care that their service has earned them."

Last year, VFW's NVS network of 2,000 service officers helped more than 590,500 veterans receive \$14.62 billion in VA benefits, including back pay. Among other locations, VFW service officers are located in 26 pre-discharge claim sites across the U.S. and abroad, with locations in Europe, Guantanamo Bay and Korea being covered remotely by service officers.

Putting Veterans First: Is the Current VA Disability System Keeping its Promise?

The following is part of the testimony by Ryan Gallucci, Executive Director, Washington Office of the VFW before the United States Senate Committee on Veterans' Affairs. The complete article can be found at www.VFW.org, under Media and Events.

WASHINGTON -- When a young American raises their right hand, swears an oath, and signs DD Form 4—the enlistment contract—they agree to surrender their personal freedoms, obey all lawful orders, risk life and limb, and if ordered, march into combat. In return, that contract entitles them to pay, health care, and benefits earned through service and sacrifice. That is not charity. That is a contract. And every man and woman who wore the uniform has already honored their end of it. The nation must honor that contract.

Yet lately, we have witnessed an appalling resurgence of old, poisonous rhetoric. Recently, The Washington Post has smeared America's veterans as freeloaders, insinuating that their hard-earned benefits are too generous and are part of a system plagued by fraud. They talk about the cost of veterans' health care as if it were some line item to be trimmed, rather than the moral obligation of a nation that has been at war for a quarter of a century. These attacks are beneath the dignity of the country our veterans defended.

We have seen this playbook before. In 1933, the National Economy League and the Economy Act gutted veterans' benefits, leaving many homeless and hopeless, and some dead by their own hand. In 1956, the so-called Bradley Commission tried to do it again, suggesting benefits be stripped from the "less disabled" and questioning the validity of conditions related to toxic exposure. Now, in 2025, we are watching the same poisonous ideas reemerge in slicker packaging. These bad ideas failed then and they should be put to rest yet again. Let's deal with the facts.

Fraud exists in every system that handles money—Medicare, Social Security, and yes, the Department of Veterans Affairs (VA). But it is rare, investigated, and prosecuted. It is not the identity of America's veterans. Those who claim that disability benefits are riddled with "fake" conditions like tinnitus, post-traumatic stress disorder, or chronic pain, are either ignorant or deliberately cruel. These are the signature wounds of modern warfare. Invisible does not mean imaginary.

And if someone thinks the passage of the historic PACT Act "lowered standards," I invite them to stand in the burn pits of Iraq or

Afghanistan and breathe what our troops breathed. Congress did not lower the bar, it finally leveled the field.

We should also address the myth that working veterans should not receive compensation. VA disability is not welfare. It compensates for loss of earning capacity, for the daily toll of living with injuries and illness that never go away. A paycheck does not erase a traumatic brain injury. A job does not make a missing leg grow back.

What truly drives bad behavior is not veterans, it's bad policy. When you design a system that forces veterans to reach 50 percent disability just to collect both retirement and disability pay, or 100 percent just to afford health care for their families, do not be shocked when veterans seek those higher thresholds. Fix the system, and you fix the incentives. If you want to crack down on exploitation, start with the real predators—the claim sharks who charge illegal fees, falsify paperwork, and profit from veterans' confusion and pain.

And let's ask a harder question: Why now? Why are veterans being identified as the problem, while billionaires dodge taxes and corporations thrive on defense contracts? Maybe it is because it is easier to scapegoat those who cannot fight back politically, the same way it was in 1933.

The all-volunteer force is the backbone of our national defense. For 25 years, it has borne the burden of continuous war and global deployments. Those volunteers kept their promise. They served with honor. Now the country must keep its word.

The VFW calls on Congress, the Administration, and every American citizen to Honor the Contract. Do not balance the budget on the backs of veterans. Do not rewrite history to make our heroes into freeloaders. And do not forget that the benefits our veterans receive today built the American middle class after World War II. They made this country stronger.

The Truth About VA Claims and Accredited VSOs

The Washington Post claimed

that Veterans Service Organizations (VSOs) encourage veterans to file as many claims as possible to exploit the system. VSOs have been labeled as the "disability industrial complex." These suppositions are insultingly false. For VSOs, the reality is that providing the human service of accredited VA claims assistance is a large financial liability, costing the VFW tens of millions of dollars across our enterprise every year. We take on this duty to ensure that new generations do not suffer the way previous generations did.

When we train our representatives, they are instructed to work with the veteran to file a claim for any condition that the veteran believes is related to or caused by service. When our accredited representatives meet with veterans, we discuss the regulations and always file an ethical claim. We never exaggerate or embellish a claim in any manner. In fact, we have even invited the VA Office of the General Counsel (OGC) to audit our training program to show our practices. If we were not confident that we are in full compliance with OGC requirements, why would we call attention to ourselves? That was more than four years ago. We are still waiting. Yet, the venerable *The Washington Post* chose instead to associate us with the bad actors who continue to take advantage of veterans, family members and their survivors. Sadly, the Post failed to mention that our organization has been the leading voice in the veteran community against fraud for years.

As an accredited organization authorized to prepare, present, and prosecute claims before VA, VFW accredited representatives are subject to the rules and regulations set forth by the Department of Veterans Affairs under 38 CFR Part 14. These regulations are very clear about conforming to ethical standards, which among other things states that "all individuals providing representation are required to be truthful in their dealings with claimants and VA" (38 CFR 14.632 (2)). This citation invalidates the point made by *The Washington Post* that VSOs encourage claimants to seek benefits to which they may not be entitled or otherwise misrepresent what the claimant is seeking. Message From Your National Council Member

The National Council of Administration met in Kansas City on September 20-21, 2025, which resulted in me not attending our Department Fall Conference. National Headquarters and the 52 Departments make every effort to deconflict schedules but sometimes the calendar simply runs out of days! I will attempt to make up for lost time at our Midwinter Conference, and I invite you to ask questions you may have pertaining to the National Council.

One of the key responsibilities of the Council is to “approve and adopt an annual budget. The National Council of Administration shall have full power to fix salaries of all officers and employees of the Veterans of Foreign Wars of the United States.”

The finance committee examined in detail the proposed budget of \$102.6 million presented by Quartermaster General Garduno and recommended adoption by the council, which we did.

Additional topics discussed at the meeting were:

1. Paystructure and adjustment to the Minimum and Maximum levels. Following the recommendations of CBIZ, a national provider of financial, insurance, and advisory services, the Council approved a 3.3% increase to the pay levels. This increase ensures national headquarters employee compensation remains competitive to attract and retain highly qualified employees. The financial impact was minimal, affecting 26 employees.
2. Fund Raising – The VFW contracts with Innovairre, the worldwide leader in fundraising supporting nonprofits and agencies. Recognizing we need to spend money to make money, this company continues to increase solicited donations to the VFW. Innovairre also guarantees a level of revenue. That means if their fundraising efforts fall short of the contract terms, Innovairre contributes the difference.
3. THC infused beverages – Many of our younger members prefer THC infused beverages to alcohol. Representatives of the Torch beverage company participated in a lively discussion about the pros and cons of such drinks after which the Council entered into an agreement with Torch authorizing the company to advertise themselves as a supporter of the VFW.

This 81st such Legacy flight involved approximately 30 veterans. Delta hosted a nonstop flight from Atlanta to Deauville, Normandy Airport on June 1, arriving in Deauville on June 2 and returning to Atlanta on June 9.

The veterans, while in Normandy participated in a series of special commemorative events that honored the memory, legacy and sacrifice of the service members – fueling cross-cultural connection and education. The veterans were honored in the many towns, villages and schools in the area. The citizens, young and old, dressed in period clothes, driving restored jeeps, trucks and parachuted out of planes all to commemorate their heroes, the American G.I.

These events are all a part of the D-Day Festival Normandy. It takes place along the entire coastline of D-Day and the Battle of Normandy, from Pegasus Bridge to Sainte-Mère-Eglise, including Ouistreham, Arromanches, Pointe du Hoc, and of course the five iconic sectors of Utah Beach, Omaha Beach, Gold Beach, Juno Beach and Sword Beach. In 2026, the Festival will run from May 30 – June 14. More information about the Festival can be found by googling “Normandy D-Day Festival 2026.”

Another Sixth District poppy display went to the National Convention. We were very honored to take the display to Columbus, Ohio.

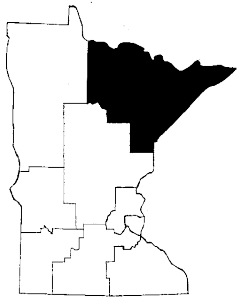

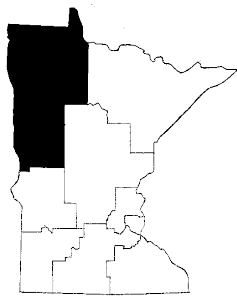

Washington - The Veterans of Foreign Wars (VFW) is proud to announce it has set a new milestone for its National Veterans Service (NVS) program by recouping \$16.2 billion in total compensatory awards for the more than 608,000 veterans it represents.

"Nothing makes me prouder than the work VFW Accredited Claims Representatives do day in and day out for veterans, transitioning service members and surviving dependents," said VFW National Commander Carol Whitmore. "It is astonishing to me that this profound amount of \$16.2 billion was recovered by men and women who do this service officer work free to the clients they assist. I am so grateful they are a part of our great organization."

The NVS Accredited Service Officer network is comprised of 2,278 dedicated professionals who are employed by the VFW, partner nonprofits, as well as state and local government agencies nationwide. Each service officer is accredited by the Department of Veterans Affairs (VA) to provide free claims assistance to transitioning service members, veterans, their families and survivors. In the last year alone, this network processed approximately 164,000 new VA claims. Of those new claims, about 14,000 were filed through the VFW's Pre-Discharge Claims Program, which supports service members as they prepare to transition out

of the military. In all, NVS represented more than 608,000 claimants.

"Every day, our VFW Accredited Service Officers show the tenacity, dedication and genuine care that veterans deserve," said VFW NVS Director Michael Figlioli. "They stand shoulder-to-shoulder with those who wore the uniform, guiding them through the VA claims process and making sure they receive the benefits they've earned. I am truly humbled by their commitment, integrity and the life-changing impact they make for veterans and their families."

VA disability compensation is an earned benefit for veterans whose injuries or illnesses were sustained or aggravated during their military service. Although guaranteed by law and embedded in the promises made at enlistment, this benefit is not automatically granted. Veterans must establish service-connection by demonstrating three critical elements: an event, exposure or injury that occurred during service, a current diagnosis and a medical nexus connecting the two. Once eligibility is established and service connection is confirmed, disability compensation is provided to help offset the effects service-related conditions have during a veteran's lifetime.

Legislative Report

As your state and national legislative chair, I have a request for all of you. The National Legislative team in Washington DC has asked every state to ask for personal stories from their members and veterans that have been affected by the lack of legislation on our priority issues. For example, who has been harmed by Claim Sharks? Who has looked for alternative methods of treatment for PTSD? How about veterans that would benefit from the passing of the Major Richard Star Act? These

veterans are not receiving their full benefits due to offsetting disability pay and retirement benefits. These personal stories will give our state officers the ability to make an impact with our congressional members when we meet with them in Washington DC in March. We need the stories from every congressional district if possible. Thank you in advance.

On the state legislative side, the Commanders Task Force (CTF) has established the number one priority for the next legislative session. It is property tax exclusion for disabled veterans. Currently 70-99% disabled veterans are capped at \$150,000. CTF is proposing that this increase to \$225,000. For 100% disable veterans the current exclusion is \$300,000. The proposal would increase to \$450,000. This is way overdue. As we all know, costs have risen dramatically over the last few years, yet the exclusion has not. The state session starts in February, and I will send out updates.

duty bound to tell the veteran the truth, not what they want to hear. To portray accredited representatives in the same light as unaccredited individuals, who in fact do take advantage of the system, is insulting to the thousands who have dedicated their life's work to assisting the most vulnerable in achieving the benefits that are provided by law.

The PACT Act was by and large the most significant veteran legislation passed since the Agent Orange Act. It righted the wrong and corrected the unjust perception that many of the illnesses or diseases suffered by those who had been deployed were imagined and not real. For the thousands who were told that their breathing issues and rare cancers were unrelated to their service, it was recognition not just of those types of maladies but of all the downstream effects as well. Rhinitis, sinusitis, irritable bowel syndrome, and other life-changing injuries were proven to be side effects of breathing bad air and particulates from the toxins created by burn pits. Since then, we know it was not burn pits alone that have been causing illnesses. There are many other sources of exposure such as chemical, airborne, and radiation to name a few. The law requires continued medical research and reporting because we now know that it takes months, even years for injuries to manifest. Veterans did not ask what was being burned, to which chemicals they were exposed, or how it would impact their lives after service. They did their jobs, upheld their oaths, and executed the mission. Sadly, it took the government far too long to do its job. For many veterans, relief and treatment came too late. Although it is easy for some to dismiss their suffering as too costly to the taxpayer, this is the cost of sending our young men and women to war.

Many of our colleagues would gladly trade places with those of us who can walk a flight of stairs without running out of breath. Some have not had a full night's sleep for decades because their bodies reflexively interrupt them, so they do not suffocate to death or die of cardiac arrest. Others would certainly give up the cocktail of medications they may have to take for the rest of their lives just to return their body systems to as normal as possible, not to mention the physical or psychological side effects. I am sure that almost all would trade the potential weight gain, body aches, headaches or other side effects for normalcy.

Most veterans led full and active lifestyles during service, even after, until they began to experience medical issues that impact their lives. For some, they can no longer manage the activities of daily living. Others cannot function in what society would consider normal. They cannot be around people in social settings, they cannot leave their homes due to their fragile state, they cannot hold a job. Are we suggesting these issues are contrived just to bilk the government out of more money? That would be an awful way to live for a few dollars more. It is even worse to suggest that the government that sent them to multiple deployments should not help provide for their basic needs or provide post-deployment health care for their service-connected injuries or provide financial support when it was the government that sent them off in the first place. The duty to make

them whole is written in statute and continues to be the obligation of the United States.

The legally authorized benefits that veterans have earned and deserve must never be politicized. The payments they receive offset lost wages due to their service-connected disabilities. To deny these in any form is shameful, especially when proposed by the 99 percent who have never worn the uniform of our great nation. Many espouse to be advocates for veterans. Often they shroud themselves in a cloak of nobility and purpose portraying themselves as champions for those who have given all. They take to the airwaves, social media, town hall meetings and election speeches decrying the lack of effort in stemming the tide of suicide. They point out with great vigor the lack of basic mental health care and wraparound services for those who have served their nation and are struggling to readjust. However, when the lights are off, the microphones are put away, and the crowds disperse, they are among the first to say the system is ripe with fraud. How hypocritical and disingenuous.

For the last several years, the Veterans Benefits Administration (VBA) has been processing more claims than ever. New legislation that provides enhanced benefits is one reason; strong marketing campaigns and promoting VA provided health care and benefits is another. Almost every month VA is touting another "record" in completing claims for benefits. Millions have been processed over the last few years. The Washington Post suggests that many claims are fraudulent. Yet the VA Office of Inspector General (OIG) has prosecuted very few persons because most claimants are not fraudsters. They are not seeking to steal unearned benefits. Like with every system (Social Security, Medicare, and others included), there are those who seek to enrich themselves and defraud the system. These are few compared to hundreds of thousands of claims that are not fraudulent. Most seek only that which was promised. To continue to press the tired, old narrative that veterans are hustlers has been disproven time and again. It is hard to think that those who have lost a limb or an eye in service did so just to defraud the government. What we find interesting is that there has been fraud and theft committed by employees of VA itself who are people in a position of public trust very much like accredited representatives. These occurrences have barely garnered attention. Several employees in a VA Regional Office were found to have been stealing identities and selling information on the black market. Others were recently found to have been processing fraudulent claims for VA benefits, then collecting large sums of money once the claims were approved. These instances made headlines for a brief moment then disappeared from front pages and newsfeeds. *The Washington Post* would have been better served by looking more closely into the theft of taxpayer funds by those entrusted to guard it, rather than malign the honorable service of thousands of veterans, family members, and survivors just trying to make it to the next paycheck.

Prepare to be Checkmated

Edwin "Ed" Albrecht was born in Minneapolis March 22, 1925. He grew up in Robbinsdale, graduating from Robbinsdale High School in 1943. It should be noted that as a very young man, he became interested in the game of chess.

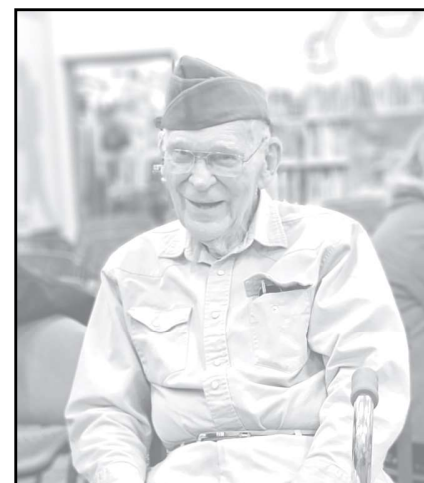
As was required by all young men, he registered for the draft in May, 1943. Ed was inducted into the U.S. Army at Fort Snelling Military Base on July 15, 1943 and sent off the Jefferson Barracks just South of St. Louis, MO. He applied for and was accepted to the Army Specialized Training Program in Fargo, ND for pre-engineering training. This program was closed on March 15, 1944. Everyone was sent off to infantry training.

Ed was assigned to the 42nd Rainbow Division in Muskogee, OK where he graduated from basic training in June, 1944. Some of the graduates were sent off to other units as replacements. He remained with the 42nd and had to receive further training in the use of the Browning Automatic Rifle (BAR) before the unit was sent to Camp Kilmer, NJ.

In November, 1944, the unit left by troop ship for Marseille, France. Once at sea, everyone on the ship was sea sick. Ed noted that the seasickness passed in a couple of days and that the food was not much to write about. Once they disembarked, the troops were sent by troop train to Strasbourg and then on to Hatten, FR. Operation Nordwind (a continuation of the German attack called the "Battle of the Bulge") forced Ed and his unit to march all night to "straighten out" the U.S. lines.

Several weeks later, his unit had advanced to Hageunau on the Moder River. Ed was assigned duty in a factory and had a clear view of an open field. He observed white clad figures approaching. When they were about 30 yards away, he attempted to fire his BAR. The firing mechanism had gotten so cold that it frozen and would not fire. He wisely retreated back to a command post and was later pulled back to a rest area.

On March 15, 1945 the entire Army front line began to advance toward Germany. It was then that Ed was wounded by a "tree burst" (a mortar shell lightly fused to exploded when it hits a tree branch). He was evacuated to a field hospital, then a general hospital and finally back to the States. After rehabilitation, Ed was assigned as a guard at a POW camp in Hatch, NM (north of Las Cruces).



March 1945 found Ed being discharged out of the Army through Fort Bliss.

Once back in Robbinsdale, Ed took advantage of the G.I. Bill and completed 4 years of education to become an optometrist. While in school, he met and married Loretta Jackelen. They moved to Wabasha, MN in 1950 where he opened his optometry practice.

The family grew to include one boy and three girls. Ed retired after 40 years in 1998. His son and wife both died in 2007.

Ed needed something to do after retirement so he renewed his fondness for playing chess. For whatever reason, he had given up chess in 1943. He joined the Rochester Chess community and began to play twice a week.

In 2011 at the young age of 86, Ed played in his first rated, sanctioned chess tournament. Winter, however, had its toll on his chess game. He would have to leave for home before it got dark so he would forfeit his last games. As he developed some health issues, Ed stopped showing up regularly at the chess club.

It should be noted that at the age of 83, Ed took up playing the acoustic guitar. It was something that he had always wanted to do.

He moved into a senior living apartment at the Augustana Apple Valley Villa where he lives by himself. He plays his guitar for residents of the memory care unit. A long-time friend frequently stops in for a chess game.

The guitar rests upright on its stand ready to be played AND the chess table is ALWAYS set up, ready to go.

Be forewarned, Ed always lets you select the white pieces, which gives you the first move, and then begins to distract you as he talks about local events. Before you know it, you are checkmated!

From Farm to Mechanic

Earl E. Erickson was born April 3, 1934 in Minneapolis and grew up on the family farm in Sturgeon Lake, MN.

On March 25, 1953, he along with four friends drove to Duluth and joined the Air Force. Earl was sent to Lackland Air Force Base, Texas for basic training and then on to Sheppard AFB, also in Texas. He completed his training as an aircraft and engine mechanic.

Earl was assigned to the 582nd Air Resupply Group where he worked on B-29 Super Fortresses and their engines. In February 1954, the 582nd Air Resupply Group deployed their aircraft along with its Air Materials Assembly Squadron and support staff to RAF Molesworth. Their operational base in England.

The 582nd was assigned to the U.S. Third Air Force and provided the bulk of its air support to the Army 10th Special Forces Group. As such, the 582nd was involved in special operations under the direction of the CIA.

In addition to ground-based repair and maintenance of the aircraft and the engines, Earl had several opportunities to fly as the airplane flight engineer. On one such occasion, the plane left for a 14-hour flight with a 6-person squad of special forces troops and their equipment. After 2 flights over the drop zone, the plane was empty and on its return flight home.

While in England, Earl met and married his wife Ivy. They had a newly baby boy which caused his service time to be extended by 3 months. After 4 years, 3 months and 7 days, Earl and family were back in Duluth.



It was June, 1957 Earl began work at the Duluth Pittsburgh Glass Company where he was trained as a glazer. He transferred to the Minneapolis Harmon Glass Company in 1973. Using his window making skills, he was sent to various locations to do onsite, from scratch, window fabrication. He retired from full-time employment in 1973 and began working part time for United Glass where he continued as a glazer. Final retirement occurred in 1983.

Earl has 2 children - a boy (Wayne) and a girl (Linda). Wayne has followed in his father's footsteps. Both children live near Earl.

Over the years, Earl has restored several vehicles: Fordson Major tractor, 1950 2-door Ford Sedan, 1951 Henry J car, and a 1950 Ford ¾ ton truck.

Service and maintenance on the two cars has kept Earl busy over the years.

Living on his own, he can be found driving his cars on the streets of Andover and Ham Lake.
