Warroad and St. Louis Park on Top VFW 'A" and 'AA' Hockey Tournament

The Two years ago, the VFW State Youth Activities Committee voted to eliminate the VFW District Playoffs from the VFW Hockey Program. This was due to a lack of District participation from over half of the VFW Districts. COVID 19 played a big part in the cancellation of the 2020 and 2021 VFW State Hockey Tournaments. In 2022, the VFW Hockey Program got the 'kickstart' it needed to keep the Program alive with the advent of the VFW State Invitational Bantam Hockey

Tournament. In essence, this is the First VFW State Invitational Bantam Hockey Tournament since 1956 and 1957 - the first two years of VFW Hockey in Minnesota.

In 2019 an effort was made to bring back more Bantam Hockey Teams to the VFW Hockey Program. Our District and State Tournaments were divided into two classes (tournaments), 'A' and 'AA' Bantams. This was the first year of that experiment. If the 2019 VFW State Bantam Hockey Tournament is

an indication, the experiment was a SUCCESS! When Minnesota Hockey created a 'AA' Bantam classification, it made it difficult for 'A' Bantam Teams to compete in the VFW State Bantam Hockey Tournament, which invited both classifications to play. With that said, we lost a lot of 'A' Bantam Teams from the VFW Hockey Program. Thief River Falls VFW Post 2793 accepted the challenge of this split tournament. This required

The Veterans of Foreign Wars (VFW) is proud to announce the inaugural VFW Day of Service — a dedicated day of service led by VFW members throughout the country and the world.

The VFW Day of Service is an outgrowth of the organization's #StillServing campaign launched in 2020 to recognize the ongoing dedication of veterans and service members who continue to serve their communities. VFW Day of Service, led by veterans and in concert with other organizations and civic groups, is open for anyone to participate. The inaugural VFW Day of Service kicks off the first Saturday in May (May 7), marking the start of veteran-led community service projects to take place throughout the month.

"The positive feedback from VFW members and the communities we serve tells us the stage is set to expand our #StillServing initiative," said Fritz Mihelcic, VFW national commander. "We have already seen how the campaign amplifies the

volunteer efforts and camaraderie of America's veterans. The time is now to take its visibility to the next level."

Veterans are more likely than civilians to volunteer in their communities, according to a recent civic health survey of veterans. The same study showed veterans donate to charities, register to vote, and are involved in their communities and local government at a greater rate than their civilian counterparts.

"We are calling on all VFW Posts and members across America and around the world to join in the VFW Day of Service by planning an activity for May 7, or at another point during the month, to show that we never stop serving" said Mihelcic.

The VFW urges its members and all veterans to visit <u>VFWDayofService.org</u> to register their event on the interactive Day of Service map and receive a special participation decal, or find a local event to join and see what other veterans around the country are doing to make a difference.

VA Proposes to Add Rare Cancers Related to Environmental Exposure

March 1, 2022

WASHINGTON — The Department of Veterans Affairs intends to propose • adding certain rare respiratory cancers to the list of presumed service-connected disabilities in relation to military environmental exposure to particulate matter.

VA determined through a focused review of scientific and medical evidence there is biologic plausibility between airborne hazards, specifically particulate matter, and carcinogenesis of the respiratory tract, and that the unique circumstances of these rare cancers warrant a presumption of service connection.

Based on these findings, VA's Secretary is proposing a rule that will add presumptive service connection for several rare respiratory cancers for certain Veterans. The cancers under consideration include:

- Squamous cell carcinoma of the
- Squamous cell carcinoma of the trachea.
- Adenocarcinoma of the trachea.
- Salivary gland-type tumors of the trachea.

- Adenosquamous carcinoma of the lung.
- Large cell carcinoma of the lung.
- Salivary gland-type tumors of the
- Sarcomatoid carcinoma of the
- Typical and atypical carcinoid of the lung.

"This is the right decision. The rarity and severity of these illnesses, and the reality that these conditions present a situation where it may not be possible to develop additional evidence prompted us to take this critical action," said VA Secretary Denis McDonough. "We'll continue to hold ourselves accountable to Veterans to provide more care, more benefits and more services to more Veterans than ever before.'

VA intends to focus its rule on the rare respiratory cancers above in Veterans who served any amount of time in the Southwest Asia theater of operations and other locations. VA will invite and consider public comments as part of this process.

Once rulemaking is complete, VA will conduct outreach to impacted veterans and survivors to inform them about potential eligibility.

VA Publishes Interim Final Rule for Suicide Prevention Grant Program

March 9, 2022

WASHINGTON – As part of the Department of Veterans Affairs' and national suicide prevention efforts, VA is publishing an Interim Final Rule March 10, 2022, implementing section 201 of the Commander John Scott Hannon Veterans Mental Health Care Improvement Act, known as the Staff Sergeant Parker Gordon Fox Suicide Prevention Grant Program.

Publishing this rule will specify grant eligibility criteria, application requirements, scoring criteria, and other elements necessary to implement this grant program.

The SSG Fox SPGP is a threeyear community-based grant program that will provide financial assistance to eligible entities to provide or coordinate the provision of suicide prevention services for eligible

individuals and their families.

"Communities play an important role in ending Veteran suicide," said VA Secretary Denis McDonough. "This grant program will invest in and seek to strengthen local community capacity to conduct outreach to Veterans, other eligible individuals, and their families and provide them with suicide prevention services and

VA anticipates publishing a Notice of Funding Opportunity in April with instructions on how to apply for a grant under the SSG Fox SPGP. Staff Sergeant Parker Gordon Fox Suicide prevention grants information.

The official version of this rule is scheduled to publish in the Federal Register March 10, 2022. However, the document is available for previewing.

Chairman Takano Urges Members to Remember our Promise to Veterans

March 9, 2022

WASHINGTON — Today, House Committee on Veterans, Affairs Chairman Mark Takano (D-Calif.) released the following statement after the House of Representatives passed H.R. 2471, an omnibus consisting of all 12 fiscal year 2022 appropriations bills and supplemental funding to support Ukraine. The omnibus includes three provisions advanced by the Committee to support our nation's

"Along with critically important funding to keep our government open and support Ukraine, the omnibus we just passed through the House includes three key bills advanced by our Committee," said Chairman Takano. "These provisions will ensure VA can competitively recruit and retain nurses and physician assistants, provide equity in burial for National Guard and Reserve Members, and increase funding for VA's sought after VET TEC Program.

"I'm proud that Democrats and Republicans came together to support \$13.6 billion in aid that is urgently needed for Ukraine. This expense is a necessary one, but let's not forget our unfinished business of caring for toxic-exposed veterans. When we make major funding decisions like these, we must remember that we have made promises to our servicemembers that we have not kept—that includes funding the healthcare and benefits we owe our veterans. We can both fund aid in Ukraine and support our veterans. These are not mutually exclusive they only require the will of Congress.

I would hope that providing healthcare and benefits to veterans exposed to toxic substances on our watch is met with the same bipartisan urgency we saw tonight. Today's servicemembers and tomorrow's veterans need to know that we will not forget them once they get out."

The omnibus includes veterans provisions that will:

- Help VA competitively pay nurses and PAs (Rep. Underwood): Increases the maximum rate of basic pay for VA nurses and physician assistants, allowing VA to offer more competitive salaries to registered nurses, advance practice nurses, and physician assistants in high cost-of-living markets.
- Ensure equity in burial for National Guard and Reserve Members (Rep. Pappas): Would allow NCA to provide individual states the ability to decide who they choose to inter in their state veteran's cemeteries and removes any potential barrier for those states who may wish to open their application process. This ensures National Guard and Reserve members can be buried with fellow servicemembers.
- Increase funding for Veteran Employment Through Technology Education Courses (VET TEC) (Rep. Levin): Increases funding in Fiscal Year 2022 for VET TEC from \$45 million to \$125 million due to the high demand and usage of the program. This allows VA to continue operating the program to the end of the fiscal year to provide more student veterans the chance to gain the high-tech skills sought by today's top employers.

Chairman Takano Comprehensive Honoring Our Pact Act

March 3, 2022

WASHINGTON - Today, House vote to change that and finally make Committee on Veterans' Affairs good on our promise to toxic-exposed Chairman Mark Takano (D-Calif) made the following statement after his comprehensive bill, H.R. 3967, as amended, the Honoring Our Promise To Address Comprehensive Toxics Act Of 2021 Or Honoring Our PACT Act. passed the House of Representatives with a bipartisan vote of 256-174. This legislation will finally treat toxic exposure as a cost of war by addressing the full range of issues impacting toxicexposed veterans including access to earned benefits and healthcare through the Department of Veterans Affairs (VA). It has the strong support of 42 Veterans Service Organizations, the Biden-Harris Administration, and advocates Jon Stewart And John Feal. "For too long, Congress and VA have been slow to act on toxic exposure-

but today, the House took a bipartisan PACT Act," said Chairman Takano. "After years of diligent input from toxic-exposed veterans, my colleagues, our staff, VA, and VSOs, we passed the most comprehensive legislation to date to treat toxic exposure as a cost of war and ensure that all toxicexposed veterans can access the care and benefits they've earned. This fight is not over, but I will not rest until our veterans have a guarantee in statute that their government will take care of them when they come home—no matter the cost. I'm so grateful for the strong support from Speaker Pelosi, President Biden, and our dedicated VSOs and advocates, and I look

MN VFW Legislative Report

By Jennifer Shumaker, Legislative Chairperson

The VFW annual Legislative Conference has provided an opportunity for VFW leaders from each state to personally lobby their respective lawmakers and watch as the VFW's current Commanderin-Chief testifies on Capitol Hill before the House and Senate Veterans' Affairs Committees on behalf of veterans. National Council Meeting/Commander-in-Chief Testimony Washington, DC was held February 27-March 3. During this time, I was meeting with our local representatives, via Zoom meeting, to go over our VFW legislative priorities.

Benefits

The VFW urges Congress to:

- Pass H.R. 3967, Honoring our PACT Act of 2021, and S. 3003, COST of War Act of 2021. These bills would help millions of veterans by establishing a framework to address any toxic exposure, foreign or domestic, past, present, and future. This legislation would help Atomic veterans and Vietnam veterans, including those who served in Thailand, Cambodia, and Laos, as well as in the Middle East, Afghanistan, K2, and beyond. They would add to VA's list of presumptive conditions and provide health care for all toxicexposed veterans.
- Pass H.R. 3402 / S. 976, Caring for Survivors Act of 2021, to finally increase DIC payments to survivors, reaching parity with other federal agencies.
- Pass H.R. 5666 / S. 3025, Servicemembers and Veterans Empowerment and Support Act of 2021, which would require VA to modernize the MST definition to include technological abuse, codify the standard of proof for MST disability claims, review VA's MST training for claims processing, and examine barriers and challenges MST survivors experience with inpatient mental health care.



Retirement and Military Personnel The VFW urges Congress to:

- Pass H.R. 1282 / S. 344, Major Richard Star Act, which would enable Chapter 61 veterans who sustained combat-related injuries to be entitled to DOD retirement pay and VA disability compensation without offset.
- Enact legislation that would create a new online feedback tool for military housing, similar to the GI Bill Comparison Tool, to serve as a central point of information for congressional oversight.
- Conduct periodic Committee on Armed Services hearings on transition to ensure DOD compliance with the law.
- Pass S. 1291, Record of Military Service for Members of the Armed Forces Act of 2021, which would enable accurate accounting of service periods and milestones for all Active and Reserve Component members via a single, standard record of military service.

Economic Opportunity

The VFW urges Congress to:

Pass S. 1093 to establish a fourth administration in VA with an exclusive focus on economic opportunity benefits in order to provide adequate oversight and resources.

- Pass H.R. 1361 / S. 444, AUTO for Veterans Act, allowing eligible veterans to receive auto grants every ten years.
- Provide continued funding and rigorous oversight for employment training programs that show measurable outcomes such as the Veteran Rapid Retraining Assistance Program (VRRAP), VR&E, and VET TEC, to include passing H.R. 2335, VET TEC Enhancement Act of 2021.
- Pass legislation that would provide equity in GI Bill benefits for Guard and Reserve members, in-person and online students, and student veterans with child care needs, to include S. 2644, GRAD VA Educational Assistance Parity Act of 2021.

Health Care

The VFW urges Congress to:

- Pass H.R. 3575 / S. 1944, Vet Center Improvement Act of 2021, which would evaluate productivity expectations for readjustment counselors and set guidelines for what type of workload each Vet Center counselor should maintain.
- Pass H.R. 4673, Ensuring Veterans' Smooth Transition Act, which would automatically enroll eligible veterans in VHA to provide a seamless transition of health care.
- Pass H.R. 239, Equal Access to Contraception for Veterans Act, which would provide women veterans access to the same nocost contraceptive care as their non-veteran counterparts.
- Pass H.R. 5575, VA Nurse and Physician Assistant RAISE Act, which would increase pay for nurses and other medical positions, thereby making VA salaries competitive with those in the public sector.
- Instruct VA to include protective factors, such as VA benefits usage, in the annual suicide prevention report.

forward to working with Senator Tester to pass truly comprehensive legislation through the Senate and send it to the President's desk. Toxicexposed veterans do not have time to wait."

The Honoring our PACT Act will:

- Provide Priority Group 6 health care for over 3.5 million toxicexposed veterans
- Provide extension of combat eligibility for health care from 5 to 10 years with a one-year open enrollment period for those veterans who missed their window.
- Streamline VA's review process for establishing toxic exposure presumptions
- Concede exposure to airborne hazards/burn pits based locations & dates of service
- Require medical exams/opinions for certain veterans with toxic exposure disability claims
- Add hypertension and Monoclonal Gammopathy Undetermined Significance to the list of presumptions for Agent Orange exposure
- Establish a presumption of service connection for respiratory illnesses and cancers related to burn pits/airborne hazards exposure
- Create a presumption of exposure to radiation for veterans who participated in cleanup activities Spain, Palomares, Enewetak Atoll
- Allow for a new tort claim for veterans and families exposed to toxic water at Camp Lejeune
- Expand agent orange exposure to veterans who served in Thailand, Laos, and Cambodia
- Improve data collection between VA and the Department of Defense
- Commission studies related to incidents of cancer among veterans, health trends of Post 9/11 veterans and feasibility of providing healthcare to dependents of veterans
- provide Require VA to standardized training to improve toxic exposure disability claims adjudications
- Require VA to conduct outreach and provide resources to toxic exposed veterans



VFW Day of Service, led by veterans and in concert with other organizations and civic groups, is open for anyone to participate. Members and Posts are urged to visit VFWDayofService.org to register their event on the interactive Day of Service map and receive a special participation decal, or find a local event to join and see what other veterans around the country are doing to make a difference.

Uniting To Combat Hunger

The Uniting to Combat Hunger (UTCH) Grant is now open! Through this grant program, Posts and Auxiliaries that donate funds and food to their local food banks, food pantries and community kitchens may apply for up to \$5,000 in grant funding. Posts and Auxiliaries may also qualify for grant funds based on hours accumulated by members volunteering at a soup kitchen, food bank or any nonprofit organization program focused on relieving food insecurity. The grant will remain open until July 31, 2022, or whenever the budget for the program has been exhausted. The application form, complete with full guidelines, is accessible at <u>vfw.org/UTCH</u>.

Gerald H. Wraa sr. is a life member of the Bemidji VFW Post 1260 and turned 100 years young on March 11, 2022. He joined the Navy after hearing that Pearl Harbor had been bombed and served during WWII from 1942-1946.

Gerald served the destroyer U.S.S. Charles Ausburne as a 40mm gunner. The ship was first sent into the North Atlantic and then on convoy duty to North Africa. She then was reassigned to the South Pacific and the Solomon Islands. In total, the ship traveled 200,000 miles. Her service record shows that the Ausburne went to battle station 780 times and was awarded eleven (11) battle stars in eleven (11) different campaigns. It was in the Battle of St. George (Solomon Islands) where the destroyers Ausburne, Claxton and Dyson engaged and sank 4 Japanese destroyers with all hands lost. There was no loss of life or ships in this battle.

WWII Vets Honored by Czech Republic

A very special ceremony was held at Everett McClay Post 1296 on February 22 to honor two WWII veterans.

Col. Jindrich Hacker and Maj. Jan Pekár of the Czech Republic's embassy in Washington, D.C. traveled to honor Fremont Gruss and Richard Pieper for their role in liberating Czechoslovakia from the Germans in May 1945.

Gruss and Pieper entered the

army separately but served together in the 97th Infantry Division Both veterans are 98 years young. Gruss grew up in Annandale, MN and currently lives in Deephaven. Pieper was born in Keota, IA and now resides in Bloomington.

The 97th Division arrived in Europe just after the Battle of the Bulge. It then fought its way across Germany. Heavy fighting occurred at Siegburg near Cologne, at the Bridge

at Remagen. It was responsible for the liberation of the Flossenburg Concentration Camp. After crossing over to the Czech Republic, the division liberated Cheb, Marienbad, Carlsbad, and many other cities on their way to Pilsen.

The 97th Division was part of Gen. George Patton's 3rd Army, which met the Russian Army at the Demarkation Line just outside of Pilsen in the Czech Republic to mark the end of the war in Europe.

The 97th was then sent on to the Pacific where it was one of the units that occupied Japan after the peace treaty was signed.

Gruss, a member of Legion Post 259 in Excelsior, said that it is not particularily difficult to reflect on his own experiences because they happened so many years ago. Time does heal many wounds.

Pieper, a member of VFW Post 1296, along with other members of the 97th have been invited back to Pilsen for the annual Liberation Festival in early May. Even though the number of veterans attending has dwindled each year. It makes little difference to the citizens of Pilsen.

Pieper understands the Czech citizens' gratitude beyond any words. He simply adds, "they just won't forget what happened."

Gruss noted that when Memorial Day comes around each year he feels the full weight of the day through the memories of his lost friends.




