Lil LaVoy, from Cloquet VFW Auxiliary #3979, lost her battle with cancer on July 11, 2022. She was laid




# 2022-2023 State Commander Dale Hoogeveen


### Hello all

National Convention was remarkably busy for me this year. As a Page to the National District Council Members, I missed sitting with the Minnesota Delegation, but still enjoyed the convention. There were several resolutions that passed on the convention floor, and we will make sure to share the "amended" versions with you as soon as we have them available from National VFW Auxiliary Headquarters and we will discuss them at Fall Conference.

A couple of things of note from the National Council Meeting on Friday, July 22:

1. It was revealed that the December edition of the VFW Auxiliary Magazine will be the last one that will be available in printed form. Only the digital version will be available after that issue. The reason the print version will be discontinued is there was a headquarters in Kansas City. This of course is not a done deal, but I am certain there will be much debate and some real data shared in the future. We have many auxiliaries that currently charge barely what they need to cover the Five Dollar Per Cap to National and the Five Dollar Per Cap to Department; it may be time for your auxiliary to consider a dues increase for 2024.

It is not necessary to send a copy of your bond to the Department Office if you are bonding through the National Organization. Only when using an outside company is it necessary for you to send a copy of your bond to the Department Office. Bonds purchased from a source other than National require Council approval. Bonds must be purchased in the amount of DOUBLE the amount of your auxiliary assets. Bonds must be purchased no later than August 31, 2022. 990N e-postcards are due by November 15. A copy of your acceptance is needed in the Department VFW Auxiliary HQ Office. If your auxiliary files a tax return, you do not need to do the 990N, but we need a copy of your return on file in place of the 990N. YOU DO NOT HAVE TO PAY ANYTHING TO FILE THE 990N ONLINE! If you are trying to complete the 990N e-postcard online and someone is trying to charge you a fee to do it.... you are on the wrong website! Please let us help you if you need it.

# **Claims Office Update**

This past year has been an extremely productive year for your MN Claims Office. We reached over the \$500,000,000.00 mark for monies recovered for Minnesota Veterans. Further over the past couple of years we have drastically expanded our Powers of Attorneys. We represent over 35,000 claimants, which equates to 6% of all VFW claimants Nationwide. That does make us one of the top offices for number of individuals represented in our National Organization. We have conducted many hearings for appellants, and a great majority were very successful. Our people are busy for sure. All your representatives have been able to finally go to in person training once again, and it was very refreshing to be able to see some of our Veteran Service Officer comrades that we haven't been with for a couple of years now. All employees have passed their accreditation tests with flying colors, garnering average scores of 97.25%. We have been very active in a few projects. Recently we were able to achieve over \$1,500,000.00 in three separate three day projects. That was very life changing for quite a few individuals.

We have also been on a national team to help develop program

updates for VA appeals. With our help and valuable insight, we were able to help develop a portion of the program that will be very advantageous to veterans awaiting hearings. Your St. Paul Claims Office often participates in projects that help with other common issues, streamlining of claims, and giving input on form development. We are often called on by our National Veterans Service Staff or the Department of Veterans Affairs to assist in various ways.

During the past VFW National Convention in Kansas City, MO your Claims Office Director, Jon Gohn, was recognized as the National Veterans Service Officer of the Year. It was a great honor and a testament to the unrelenting work that the office staff puts forth on a daily basis. They truly are the best of the best and can hold their heads high when completed the mission statement of, "No One Does More for Veterans".

It is a pleasure assisting our Minnesota clientele, and we look forward to another successful year.

# **NO MORE DELAYS,** Pass the PACT Act Now!!

### July 18, 2022

WASHINGTON — A procedural issue required Congress to amend and pass the PACT Act again.

# **New, Easy-to-Remember** Veterans Crisis Line

July 18, 2022

Veteran having thoughts of suicide or concerned about one, reach 24/7crisis support through the new Veterans Crisis Line (VCL) number: Dial 988, then Press 1.

This shorter, three-digit number provides an easier-to-remember way to access the VCL. We're working to make sure all Veterans and their supporters know about the new number. Below are answers to some questions you might have about this change.

Why did the VCL get a new number?

The change is a result of the National Suicide Hotline Designation Act. The law authorized 988 as the new three-digit number for the National Suicide Prevention Lifeline (Lifeline). Under the law, all telephone service providers in the U.S. had to activate the number by July 16, 2022.

Because VA administers the VCL through the Lifeline's national network, the service was affected by this transition.

What does the new number mean for me?

supported millions of Veterans in crisis. This new, shorter number increases ease of access and clarity in times of crisis for both Veterans and supporters.

Like the current number, to WASHINGTON — If you're a reach the VCL, Veterans will press 1 after dialing to connect with VCL responders. Though the number is new, the Veterans Crisis Line dedicated service is still the same. And, you don't have to be enrolled in VA benefits or health care to connect.

Is the old VCL phone number going away?

No. Veterans will still be able to call 1-800-273-8255 and Press 1 to connect with responders. The VCL will also still be available by chat (VeteransCrisisLine.net/Chat) and text (838255).

What happens if I'm overseas?

The VCL's 800 number is a continental United States (CONUS)based toll-free number that remains active. Some international calls may incur a charge, depending on the caller's location and network provider.

Veterans overseas may contact the VCL through chat at VeteransCrisisLine.net/Chat.

If you prefer a phone call, you can request this within the chat venue. A responder will call you at the number you provide at no charge.

Be prepared and save the new Since 2007, the VCL has number in your phone: Dial 988, then Press 1.

# Post 9/11 Veteran **Service Bonus Available**

The report given to all council members was a realistic and well thought out description of the enormous amounts of capital it takes to run this quarter of a billion dollar non-profit.

The delegates to the National Convention considered a number of bylaw, manual of procedure, and ritual changes. These will be amended in the new podium edition of the National Bylaws Manual of Procedure and Ritual available for sale through VFW Emblem and Supply. Some time in October I would anticipate the newest edition will be available.

The discussion continued regarding Claims Shark legislation. You may have seen recent editions of the VFW Magazine and other periodicals that offer representation by an attorney in the VA claims process. The fact is that the VFW service officers are far better trained in this process than any attorney in the country. These sharks promise big wins but in the event of success they have a contract to obtain a large portion of any retroactive payments. The National Organization is on top of this issue and we need to be on our congressional members to ensure this practice is put to death. Again, there were several more issues that were considered by the Council but are too numerous to bring forth in this column. # **MN VFW National Legislative Report**

H.R. 3967 - The PACT Act This is perhaps the largest health care and benefit expansion in VA history.

The official title of Bill H.R.3967 is The Sergeant First Class (SFC) Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act. Known simply as the PACT Act or Honoring our PACT Act was passed in the evening of August 2, 2022. This act was headed by Representative Mark Tanano (D) from California's 41st District. This Bill was approved by the Senate and is sitting on President Biden's desk. After arguments and stalling by Pat Toomey (R) from Pennsylvania's 15th District citing that the bill had a 400 billion discretionary portion that they could not approve. This was proven to be incorrect.

Emails from VFW Director of National Legislative Service, Patrick Murphy stated as such "This Bill has no Pork." "This bill does not have \$400 Billion in non-veteran spending!". Feel free to read it yourself, search H.R. 3967, and view it.

This bill offers more benefits to



veterans affected by burn pits. These burn pits affect everybody (especially anyone who had to sit through a field sanitation class). This expands health care to more veterans. These benefits should come across as bipartisan and easy to approve for signature but are becoming a topic that are getting voted along party lines. This is why we need to continue to promote Veterans benefits.

Minnesota's representatives all voted in favor of the PACT Act bill.

Included in the bill are provisions for veterans who served in previous conflicts. It expands the benefits

for Vietnam veterans who have developed hypertension caused by Agent Orange specifically in Thailand at any U.S. or Royal Thai bases, Laos, Cambodia, Guam or American Samoa or the waters thereof, or on Johnson Atoll. It also includes veterans who participated in the cleanup of radioactive materials at Palomares, Spain, and the onboard fire and crash of a U.S. Air Force B-52 bomber in the vicinity of Thule Air Force Base, Greenland.

### H.R. 2192 - Camp Lejune **Justice Act**

This is the next bill to come up. The H.R 2192 Camp Lejune Justice Act. Introduced by Rep Matt Cartwright (D-PA-8th) this will assist veterans who were stationed in Camp Lejune from 1953-1987.

Currently this has only been introduced but should pick up steam quickly in Congress.

Please be sure to write your Congressperson on your thoughts regarding this bill and also write showing appreciation for Passing H.R 3976.

# **MN VFW State Legislative Report**

### **MN Omnibus Bill signed June 2022**

Governor Tim Walz ceremonially signed the comprehensive veterans omnibus bill and National Guard retention bonus bill. Governor Walz officially signed the veterans omnibus bill, SF4233, on May 10, 2022. Governor Walz also signed HF3379, which expands eligibility for reenlistment bonuses for Service Members in the Minnesota National Guard.

Highlights of SF4233 and HF3379 include:

**1. Service Bonuses** 

The bill includes nearly \$25 million in FY23 for service bonuses to post-9/11 era veterans and Gold Star Families.

### 2. Veteran Homelessness

FY23 for the design, construction, furnishing, and equipping of new veterans homes to support aging veterans in Bemidji, Montevideo, and Preston, Minnesota.

### 4. National Guard Retention

Around \$4 million will go toward enlistment incentives designed to retain the trained and ready members of the Minnesota National Guard over FY 23-25.

### **Veterans Cemeteries**

The bill includes \$830,000 annually to operate state veterans cemeteries, including operations in Redwood County.

The bills passed the Minnesota House and Senate with nearly unanimous support.

National Association of County Veteran Service Officers (NACVSO) Legislative Report

agreement does not mean we are not supporting the PACT act, tried to get CVSO points in there, but then the CVSO should be separate, and need to have as a standalone bill.

The purpose is to provide funding local governments through to VA administered grants, improve outreach and assistance to veterans and increase the number of county and tribal veteran service officers.

### **Increase veteran access to care**

S3388 -Veteran Benefits improvement actaddresses the following:

- 1. Establishes a Board of Veterans Appeals (BVA) internship and honors program
- 2. Conduct a report on improving access to BVA tele-hearings

In FY23, \$5.4 million will go toward a grant to the Minnesota Assistance Council for Veterans to provide assistance to veterans and former services members and their families who are homeless or in danger of homelessness. The bill also includes \$1.7 million annually to fund temporary housing options for veterans and former service members experiencing homelessness and to increase outreach activities to end homelessness.

3. Veterans Homes

The bill includes funding of \$10.3 million in FY22 and \$16.5 million in

Key areas of emphases are: Improving support for local government service officers

-HR4601 and S2405 CVSO act is no longer in the PACT act, cut out of Compensation & Pension (C & P) exams and Disability Benefits Questionnaires (DBQs) VHA personnel and contractors will have access to DBQs, and the VA must keep the claims office notified of all those exams, and updates.

Section 301 forces the secretary to report back to congress one year no later of elements of the report include VA systems enhanced access, intergovernmental liaisons and improve the relationship between VA and veteran advocates.



We will continue to strive to do the best, but I believe we are definitely on the right track.






Greeting 4th District members,





On April 27, 2022, Ryan M. Gallucci, Director of the National Veterans Service Office of the VFW made a presentation before the United States House of Representatives Committee on Veterans' Affairs. He spoke on the issue of predatory practices in veteran benefit claims representation.

In his presentation, he stated that the VFW has been concerned that certain businesses have been preying on veterans seeking to access their earned benefits through the Department of Veterans Affairs (VA). He noted that the VFW has proudly high-quality provided veteran representation in the benefit process for more than one hundred years. Through the VFW's accreditation with VA, its global network of more than two thousand advocates represents more than 550,000 veterans. These same veterans have received more than 10.2 billion dollars in earned benefits in 2021.

The VFW has a world-class training program subject to periodic VA audit. It is proud of the Lifetime of Advocacy our accredited representatives provide to veterans. Further, the VFW is looking to make innovations based on lessons learned during COVID-19.

When the COVID-19 pandemic struck, non-accredited consulting groups which the VFW refers to as 'Claim Sharks" started popping up. This was a perfect time for these "Claim Sharks" to exploit veterans. They aggressively advertised online for veterans to increase their ratings and finally get the benefits they deserved. Some of these companies advertised that they want to "clean up" the system and offer veterans more "choice." When you quickly read between the lines, it is discovered that these are meaningless buzz words. Some predatory companies have used the confusion created by the COVID-19 pandemic to infiltrate networks of veterans in need.

As far as the VFW and many of the other Veterans Service Organization (VSO) are concerned, if these companies want to help vdeterans, their staff should first seek accreditation with VA as accredited agents or attorneys, and appropriately file all required powers of attorney, contracts, and fee agreements with the VA Office of General Counsel (OGC) to ensure that they abide by professional and ethical standards. They would then be following the same rules the same way that accredited VSOs, attorneys, and agents have done for decades.

Legislation to reinstate penalties for companies that clearly violate VA policies almost made it through the last Congress as part of the Roe-Isakson omnibus package. Unfortunately, it was removed at the last minute.

Many of these companies enter into contracts well beyond the scope of what VA allows under law. They do not file powers of attorney, consulting agreements, or fee agreements with the VA OGC. Many of these predatory consulting agreements include a commitment by the veteran to pay the "Claim Shark" all or a portion of their increased benefits.

They also purport to provide "medical consultation," promising faster results for veterans, ignoring the VA's duty to provide medical examinations and render medical opinions for claimants at no cost to the veteran. Some of these companies go so far as to ask veterans for sensitive usernames and passwords for their eBenefits or VA.gov accounts. Lastly, recourse is minimal for veterans who believe they were scammed. Many of these contracts include binding arbitration clauses. Some even go so far as to include clauses that prohibit veterans from disclosing terms of the agreements



# **WWII Vet Honored with MN Senate Resolution**

The Fort Chippewa Post 396 in Alexandria hosted a special omelet state registry forever, according to breakfast on April 29, 2022.

The guest of honor was WWII veteran Doug Dahlheimer. He was presented a State Senate Resolution plaque presented by State Sen. Bill Ingebrigsten, R-Alexandria, recognizing his service to the United States and congratulating him on his 100th birthday, which wasi on May 9.

"It's just something that we can do for citizens that have given so much," said Ingebrigtsen. "And it's very important we acknowledge our veterans."

The VFW contacted Ingebrigsten in hopes he would send a letter to Dahlheimer. But Ingebrigsten wanted to take it further by presenting the plaque in person.

The resolution reads:

Whereas, our communities are blessed by the presence of those who have lived long lives and who are part of our living history; and whereas, having a 100th birthday is a joyous occasion and a time to honor and congratulate the celebrant; and whereas, Douglas M Dahlheimer was born on May 9, 1922; and whereas, Douglas is a veteran of WWII, having served his country honorably in the Navy from 1942 to 1946 on the USS Blue Ridge (AG2) as a fire controlman; and whereas, Douglas will be celebrating his 100th birthday on May 9, 2022; and now, therefore, be it resolved by the Senate of the State of Minnesota that is congratulate Douglas M. Dahlheimer on his 100th birthday. Be it further resolved that the Secretary of the Senate is directed to prepare an enrolled copy of this resolution, to be authenticated by the Secretary's signature and that of the Chair of the Senate Rules and Administration Committee, and transmit it to Douglas M. Dahlheimer."

The resolution will be in the Ingebrigsten.


