## **Minnesota Loses Past National** Commander-In-Chief Staum

John S. Staum, Age 87, longtime resident of Blaine, passed peacefully on September 23, 2018. Preceded in death by parents, Nels and Lydia; sister, Phyllis Peterson. Survived by loving wife of 64 years, Bernadette; children, Mark and Nancy; grandchildren, Lindsey, Jake, Nils and Lars; and greatgranddaughter, Clare.

John is a 1948 graduate of Central High School in Minneapolis. He attended St. Olaf College. John worked in Construction, Sales and Management.

Serving in the United States Marine Corps, John earned his eligibility for the Veterans of Foreign Wars during the Korean War.

John served through the



chairs of Coon Rapids VFW Post 9625, becoming Post Commander in 1961 – 1963. He went through the chairs of Minnesota's Seventh District. attaining District

Commander in 1966 – 1967. John then served through the Department Chairs and was elected as State Commander for the 1970 - 1971 He then made a run for National Commander-in-Chief and was elected to that position for the 1985 - 1986 year. Obviously, John served on many State and National Committees, where he shared his expertise and experience.

Some people accomplish their goals and get their accolades with a lot of 'noise and pats on the back'... John Staum did not work that way... John lead by example. He Dedicated a very large part of his life to the Veterans of Foreign

Jim passed away on Saturday, November 17, 2018 with his family at his side while under the respectful care of the Fargo Veterans Hospital and Community Living Center.

James Duane Vetter was born November 6, 1939 in Mosinee, Wisconsin to Bruno and Grace (Cannady) Vetter. Jim attended school in Marathon, Wisconsin graduating from Marathon High School in 1957. He attended college in Stevens Point, Wisconsin before entering the United States Air Force on February 5, 1958. His Air Force isolated tours included



Morocco, North Africa; Fort Yukon, Alaska; and Viet Nam (where he earned his eligibility for the Veterans of Foreign Wars). Jim served as a radar controller when stationed in Wadena, Minnesota; Baudette, Minnesota; and Friesing, Germany; a recruiter in Fond du Lac, Wisconsin; and two tours in Duluth, Minnesota working with NORAD forces. Jim retired from the U.S. Air Force on September 1, 1979 after 21 ½ years of service.



Additionally, many of those same veterans will have children and grandchildren who will serve in the Armed Forces. It is our and their responsibility to ensure future generations are also cared for.

The Membership Caravan conducted on November 17-18 saw three teams led by Commander Hanson, Sr Vice Commander Solheid and Jr Vice Commander Hermanson comprised of VFW and Auxiliary members travel approximately 2000 miles visiting thirteen posts to distribute membership recruiting materials and share ideas to increase success. ## George R. Cramer

Past National Commander-in-Chief 1993-1994 George R. Cramer was elected VFW Commander-in-Chief at the 94th VFW National Convention in Dallas, Texas in August 1993.

Prior to entering the military, Cramer earned a Bachelor of Arts degree in education from Loyola University in Chicago, Ill.

Following graduation he entered the U.S. Army, serving in Vietnam from October 1967 through December 1968 as an artillery surveyor with the 6/14 Artillery, 1st Field Forces. During his tour he was awarded the Vietnam Service Medal, the Air Medal and the Bronze Star for meritorious service.

Cramer joined the VFW in 1969 and is a Legacy Life Member of Post 3873 in Naperville, Ill. Cramer earned All-State Post Commander in 1972-74 and again in 1989-90, an All-American District Commander in 1976-77, a 100% Department Commander in 1982-83 and

All-State Post Quartermaster 1976-1985; 2003-08. He is currently serving as the 19th District Quartermaster where he has earned All-American honors. In addition, he has served as District and Department budget chairman and as National Chief of Staff in 1985-86, as well as serving on the National Council of Administration in 1989-91. He was selected as the Combined Veterans' Association Person of the Year.

Cramer retired as the Special Assistant to the Secretary of Veterans Affairs, serving as the Secretary's national veterans' service organization liaison. Prior to this appointment, he was the VSO liaison for the VA Chicago Health Care System and VISN 12 (Hines, Ill.), communications officer for the department's Capital Asset Realignment for Enhanced Services program. Cramer previously served eight years as assistant director for the Illinois Department of Veterans Affairs.

During his year as national commander, the VFW partnered with the VA to co-sponsor the National Veterans Golden Age Games. He traveled extensively during his term of office, including Normandy for the 50th anniversary of D-Day, where he placed a wreath at Omaha Beach in honor of those who died there.

Cramer is active in many civic and fraternal organizations including the Selective Service Board, American Legion, AMVETS and the Disabled American Veterans. He also serves on the advisory board at the Abraham Lincoln National VA Cemetery.

He and his wife Linda, son Scott, and daughter Cheryl make their home in Naperville, Ill.

## **Capital Hill Press**

As we enter the holiday season, it is important to remember our Brothers and Sisters that are struggling. "Happiest time of the year"? Not for all; for far too many the holidays are anything but that. Especially for those that have no place to call home; no place to "hang their stockings with care."

Specifically, I'm talking Homeless Veterans, and more specifically, I'm talking Homeless Veterans in Hennepin County. 65 communities in over 30 states have ended Veteran Homelessness and have the systems/policies/procedures in place to have any future homeless veterans in a place of their own within 90 days; these communities have reached what is called "Functional Zero." Sadly, Hennepin County is not on the list of those that have ended Veteran Homelessness and achieved Functional Zero.

The goal was to end Veteran Homelessness in 2014 - https://www.mprnews.org/story/2015/08/27/young-reporters Then it was 2015. Then it was 2016 - https://www.mprnews.org/story/2016/01/28/minnesota-veterans-homelessness It is now almost the end of 2018, and the newest goal I can find is by 2020 - https://mn.gov/dhs/assets/minnesota-action-plan-18-20\_tcm1053-328234.pdf

At some point, people in positions of authority need to be asked: "What are you going to do differently because what you've been doing isn't working."

The VFW believes it should be something that has been talked about for years; most notably at the August 2015 Homeless Veterans Summit at the Minneapolis VA Medical Facility: Veteran Preference. This tool was discussed at this Summit by Eric Grumdahl, the Governor's Special Advisor to End Veteran Homelessness and working through the Minnesota Department of Veteran Affairs. This tool was never adopted by Hennepin County; this tool is opposed by Hennepin County Commissioner Jan Callison, who serves as the Co-Chair of Hennepin County's effort to end homelessness.

To ensure that the Veteran Preference tool is put in place, your VFW is working with all 9 Congressionally-chartered Veteran Services Organizations – the American Legion, AmVets, Disabled American Veterans (DAV), Jewish War Veterans, Marine Corps League, Military Order of the Purple Heart (MPOH), Paralyzed Veterans of America (PVA), and the Vietnam Veterans of America (VVA) to pass legislation in St. Paul that requires that any state homeless funds must include a Veterans Preference.

Please contact your State Representative and State Senator and let them know you support a Veterans Preference. Ask them for their support for state legislation mandating a Veteran Preference for all state expenditures for homelessness. # VFW Urges VA: Add Hypertension, Agent Orange to Presumptive List

#### WASHINGTON —

The Veterans of Foreign Wars of the U.S. is calling on the Department of Veterans Affairs to add hypertension and a precursor to multiple myeloma to the current list of 14 presumptive diseases associated with contact with chemical defoliants used in Vietnam, Thailand, and along the Korean DMZ.

The VFW's case is bolstered by a new report just released by the

National Academies of Sciences, Engineering and Medicine. The report, entitled Veterans and Agent Orange: Update 11 (2018), found that sufficient evidence exists that links exposure to at least one of

the hazardous chemicals with hypertension and MGUS, or monoclonal gammopathy of undetermined significance. The hypertension finding is an upgrade from their 2014 report and MGUS is a newly considered condition.

Said VFW National Commander B.J. Lawrence, "There is no

doubt in anyone's mind that Agent Orange made veterans sick, it made their children sick, and it brought pain and suffering and premature death to many. Even though it's been a half century since they were exposed, the results of that exposure is something they continue to live with daily," he said.

"The VFW thanks the National Academies for continuing to honor the charter that Congress gave them, and we now call on VA Secretary Robert Wilkie to use his authority and recognize the science in the report to swiftly add these two illnesses to the presumptive list so that these veterans can finally receive the

assistance they earned and deserve," said Lawrence.

The VFW will continue to monitor the progress of the potentially two new presumptive illnesses. In the meantime, the VFW

encourages all veterans who served in Vietnam, in Thailand or along the Korean DMZ to contact a VFW Service Officer to discuss whether they are eligible to file a VA claim for Agent Orange exposure. **Exploring VA's Oversight of Contract Disability Examinations** 

November 15, 2018

#### WASHINGTON, DC-

Chairman Bost, Ranking Member Esty, and members of the Subcommittee, on behalf of the Veterans of Foreign Wars of the United States (VFW) and its Auxiliary, thank you for the opportunity to provide our comments on the Department of Veterans Affairs' (VA) oversight of contract disability examinations (CDEs).

Over the last 20 years, VA has more frequently contracted with private health care providers as a way to provide sound medical opinions with the intent to quickly and accurately adjudicate veterans' disability benefit claims. This contracted system has proven to be beneficial to both veterans seeking benefits and VA in ensuring veterans can receive timely and correct benefit decisions. The VFW fully supports VA's efforts to provide veterans with contract disability examination options for a variety of reasons. The most significant of which is that we believe, and veterans confirm, that private providers can furnish a largely objective opinion in evaluating a veteran's claimed medical condition.

Moreover, we hear frequent positive comments about contract exams and the outcomes for veterans. Unfortunately, since VA executed its latest contract for disability examinations in 2016 and extended work to two new vendors, Logistics Health, Inc. (LHI) and MSLA, a Medical Corporation, the VFW has seen new problems emerge which impelled us to join our partners in the veterans service organization community to call for a hearing so that this subcommittee can better assess the situation.

Under the most recent contract, VA instituted new, incredibly rigid timelines for contractors to complete exams and return records to VA. Though the recent Government Accountability Office (GAO) report

notes that VA allows 20 days for vendors to conduct routine exams, in reality the vendors tell the VFW that this leaves them a window of only about one business week in which to conduct the exams. This is an unreasonable expectation. These standards in no way reflect the needs of the veteran, nor are they favorable to VA which has a well-documented shortage of examiners at both the full-time employee and contract levels. When we ask VA about these timelines, the usual response is that VA believes veterans want their benefits completed quickly. We concur. However, VA cannot sacrifice accuracy and a positive customer experience for the sake of speed. It does not matter how quickly a veteran receives a rating decision from VA if the decision is wrong.

Since 2016 — and amid multiple disputes about the validity of VA's contract; extensions of bridge contracts; termination of one of VA's new vendors; and the solicitation of new bids — the VFW has seen a growing list of problems with VA's contract exam system. This summer, in light of these problems, we asked VA for a report on quality for the current contract examination system. After dragging its feet for more than a month, VA finally replied that they could not share this information unless the VFW filed a Freedom of Information Act request. After reviewing the GAO report, the VFW believes that the leadership of the Mandatory Disability Exam Office did not want to admit that they had not completed a quality review report for any period in 2018. With all of these factors affecting veterans' access to accurate and timely benefits, this hearing comes at a very critical time.

The VFW can summarize the problems we have seen with the current contract exam system as follows:

- Late notification of exams.
- Lack of options for veterans to reschedule exams.
- Lack of availability of adequate examiners with reasonable distance to the veteran.
- No adequate review of a veteran's claim file prior to the exam.
- Inadequate time with provider due to volume and turnaround.

#### **Late Notification of Exams**

The VFW has learned from our field

## VA Rates 70 Percent of Its Nursing Homes as Failures: VFW, Legion Demand Immediate Action

VA Rates 70 Percent of its Nursing Homes as Failures VFW, Legion national commanders demand immediate action November 14, 2018

#### WASHINGTON —

The national commanders of the nation's two largest veterans organizations are demanding that Department of Veterans Affairs Secretary Robert Wilkie bring immediate attention to his nursing home program that currently has 70 percent of its 132 homes receiving failing grades by the VA's own rating system

The call by Veterans of Foreign Wars of the U.S. National Commander B.J. Lawrence and American Legion National Commander Brett Reistad is in response to a series of scathing articles by two USA Today and Boston Globe reporters who documented substandard and negligent care at the VA nursing home in Brockton, Mass., which is one of 45 nursing homes that received the VA's lowest rating of one star. Forty-seven homes received two stars, 16 homes three stars, and 15 homes four stars. Only nine nursing homes received the VA's top five-star rating.

"While much of the media's attention has been on the proper implementation of VA healthcare legislation, we cannot forget about 46,000 mostly senior veterans who reside in these nursing homes," said the two national commanders, who collectively speak for more than 4.6 million members and their auxiliaries.

"The media reports about sub-

par care, patient neglect and safety violations at VA nursing homes are more than just disturbing," said the Legion's national commander. "Legionnaires, our friends in the VFW, and anybody who respects veterans should be angered by this," said Reistad. "These are not just patients in a home, these are people who in the prime of their lives risked their lives, and made enormous sacrifices on behalf of our country. America's veterans deserve better. We not only expect VA to fix these problems immediately, but we want transparency. Those who sleep on the job and ignore the best interests of their patients need to find a different employer."

Echoing his counterpart, the VFW national commander said

"These veterans earned the right to receive high quality care in a fullystaffed and well-managed facility. Their families deserve to know that their loved ones — their heroes are not being abandoned or abused, and America needs to be reassured that the VA is honoring our nation's promise to those who have borne the battle," said Lawrence. "The VA must improve its delivery of quality care at these facilities. It must recruit and retain only the best healthcare professionals and support staff, and it must hold all employees accountable for their actions or inactions. It is not a right but a privilege to work for America's veterans, and anything less is unacceptable."

staff and locally in the Military District of Washington about dozens of instances where veterans were not notified in a timely manner that VA had scheduled exams. In one example from Georgia, the veteran was contacted by VA's vendor, LHI, on a Thursday afternoon for an exam scheduled on Monday morning. When the veteran tried to reschedule with LHI, he was guilted into rearranging his schedule for the Monday appointment and essentially forced into calling out of work and rearranging other health care appointments out of fear that his benefits would be adversely affected. When the VFW reviewed the veteran's claim file, we noticed that not only had VA sent the exam request to LHI less than a week before the exam was scheduled, VA also failed to include accurate contact information for the veteran, which was readily available in the veteran's records.

Under the old contract, veterans were afforded more time to get their affairs in order to attend contract exams. Even the legacy contractors have complained to the VFW that the new contract makes it harder for veterans to attend exams, resulting in higher no-shows and returned exam requests to VA, either further delaying delivery of earned benefits, or worse, resulting in erroneous denial of benefits.

#### **Lack of Options to Reschedule**

Given the new compressed timeline, we hear from veterans that if they cannot make the appointments assigned to them by the contractor, they are offered only three options: attend your appointment regardless of conflicts; be reported as a no-show and VA will likely deny your benefits; or have the contractor return the appointment request to VA as a cancellation with the hope that VA issues another exam request soon. Each of these options is bad for veterans. Under the old contract, the legacy contractors were reasonably flexible with veterans, ensuring exams could be completed in a matter of weeks. The VFW received very few complaints before 2016, and even collected positive stories about the contract exam experience.

Unfortunately, under the new contract, we have seen negative outcomes for veterans and some potentially concerning business practices when it comes to rescheduling or cancellation requests. The most glaring example of this came from a veteran in Maryland who is assisted by the VFW staff here in Washington, D.C. According to the veteran's claim file, VA ordered a series of exams from LHI on October 17, 2018. On October 18, 2018, the veteran was listed in the Veterans Benefits Management System as a no-show for her exams. This obviously caught our attention and we contacted the veteran to learn what happened. The veteran told us that she was called by LHI on October 18, and asked if she could reschedule. LHI told her she could not, and they would have to return the exam request to VA. Veterans seeking benefits should not have to be concerned about contractor penalties due to their inability to properly notify them or obtain a timely exam.

In spite of this, what concerns the VFW most about this situation is that the veteran was reported as a no-show. Our understanding of the contract is that this means that LHI is still paid for the exam, even though no exam was ever completed. Again, VA's contract exams office has not been transparent with the VFW on contract exam issues, so we have no way to verify this, other than posing it as an assumption to the subcommittee in this forum. Regardless, at the very least it seems that contractors are incentivized to cut corners in an effort to meet VA's unreasonable expectations.

#### **Lack of Availability of Examiners**

Another persistent issue we have heard from offices around the country is that to meet the timeliness goals of the contract, each of the contractors is forced to schedule veterans wherever they can find an available doctor. This leads to unreasonable travel times and unrealistic appointment expectations for veterans

In Arkansas, one elderly veteran was scheduled for a contract exam in Oklahoma, more than three hours away from his home. In Washington state, another veteran in the Seattle area was scheduled for an exam more than three hours away in Oregon. In Washington, D.C., we have seen veterans sent to Gettysburg, Pa., for exams.

Another glaring example came from California, where a San Francisco-area veteran was scheduled for one exam at 3:30 p.m., more than 20 miles outside of the city, with a second exam scheduled at 4:15 p.m. back in San Francisco, making it logistically impossible for the veteran to attend both.

Fortunately, in each of these cases, the VFW's service officers have caught these unreasonable requests and worked with VA to re-

solve the issue. However, we must question the structure of a contract that forces a vendor to make these kinds of decisions.

#### No Adequate Review of Claim File/ Inadequate Time with Provider

The VFW believes the final two issues are linked. We continue to hear concerns about the adequacy of a contract examiner's review of the veteran's claim file and the time that veterans receive with providers. These have been issues that the VFW has raised prior to the 2016 contract, but these problems persist, and we believe they have been exacerbated by the new timeliness requirements of the contract.

When contract providers fill out Disability Benefit Questionnaires (DBQs) for veterans, they must verify whether or not they have fully reviewed the veteran's file. They usually affirm that they have and then go on to render an opinion. However, we have learned that the vendor selects which specific files to share with a provider ahead of the exam, meaning they likely never fully review the file. We have also heard reports that some contract providers solely rely on the claimant's pre-exam worksheet to evaluate the historic record of a condition, rather than the official claim file documents. To the VFW. both scenarios render the exam unacceptable and inadequate.

Next, we have also heard conflicting information from veterans about the time spent with providers and the attention given to their issues. We hear anecdotes that veterans see providers for only a matter of minutes and that certain

The Minnesota State Veterans Cemetery in Preston, Minnesota, is located in the First District and was dedicated in 2015, opened on Veterans Day (November 11th) 2015, and officially opened on Memorial Day in 2016. It is located off of Highway 52 in Preston. It is only the second official Veterans Cemetery in the State of Minnesota, and it sits on 169 acres of beautiful property which was donated to the State of Minnesota by Fillmore County.

State Veterans Cemeteries differ from VA National Cemeteries, but both have a common goal of providing eligible Veterans and their spouses with military burial honors within 75 miles of their home. Thus, Minnesota, Iowa, and Wisconsin Veterans may be eligible for burial at our Preston Cemetery.

Burial at the Minnesota State Veterans Cemetery is open to all Veterans who have been discharged from active military service under any condition, other than dishonorable. Their spouses, minor children, and some unmarried adult children may also be eligible for burial on the property as well. The Cemetery is able to hold 35,000 souls, and the first phase has room for about 3,500. There are already almost 400 who have been laid to rest and 700 pre-planned for the Preston Veterans Cemetery to be their final resting place. To locate your loved one, you can enter his/her name into the electronic registry on the premises, and it will tell you the location.

Burial is provided to eligible veterans at no cost – ZERO – no matter which burial option is chosen. The options include burial in casket, cremation (in-ground), or cremation (columbarium). The options of a Gravesite or columbarium niche, a pre-placed Grave Liner, a headstone or a Niche Cover, and perpetual care are included for NO COST to Veterans. Military Honors may be arranged at the Cemetery, which could include rifle volley, taps, flag folding, and flag presentation. The family, or a representative of the family, may choose their own clergy for their individual service. For a spouse or eligible dependent of the Veteran, the cost is only \$745 for all burial options.

Committal Services are held on Mondays through Fridays on a

first-come, first-serve basis. The cemetery is able to perform up to seven committal services each day, beginning on the top of the hour from 9 a.m. until 3 p.m. Committal Services are held in the shelter, which is located in a focal position in the Cemetery grounds. Then the remains are transported to the gravesite and are never left unattended.

There are planned Memorial Day Services which will be held at the Cemetery every year on the Sunday of Memorial Day Weekend. This day was chosen so that most, if not all, military and VFW and Auxiliary Members may attend these beautiful services.

Please feel free to come and visit. This place is so peaceful, and is a beautiful resting place to Honor our deceased Veterans! The grounds are open during daylight hours, seven days a week. Administrative hours are from 8 a.m. until 4:30 p.m. Mondays through Fridays. For more detailed information, please phone: (507) 765-7320, or email: info.Cem-PR@state.mn.us

required measurements or evaluations are never actually conducted, though they are reported as such on the DBQ. We have no way to verify this independently, but the volume of complaints that we hear from our service officers in the field and directly from veterans once again force us to raise this issue with this subcommit-

The VFW does support and believe in the contract disability examination concept. We have seen it work. In Wisconsin, we continue to see very positive outcomes for veterans, and our service officer even reports that when it comes to accuracy, he believes contract exams more closely match the veteran's reported experience than exams conducted internally by VA. This reinforces the VFW's core belief that unaffiliated third parties are well suited to render

objective opinions. However, even Wisconsin reports that they have seen scheduling problems for veterans they serve. We are very concerned that VA is not adequately tracking quality and customer experience for its contractors, meaning there is no real way for VA to monitor the efficacy of the contract for the veterans they serve. This is why we are left to resort to anecdotes and trends that we see around the country for our clients.

VA has a unique opportunity now as it seeks to enter into a new contract for CDEs. The new contract must factor in veteran experience, measure quality outcomes, and report transparently on these outcomes. Without this, we will continue to see erroneous denials, reported no-shows, and contractors cutting corners to try and meet unrealistic objectives.

#### **DEFINED:**

A general order, in military and paramilitary organizations, is a published directive, originated by a commander and binding upon all personnel under his or her command. Its purpose is to enforce a policy or procedure unique to the unit's situation that is not otherwise addressed in applicable service regulations, military law, or public law.

#### **VFW Department General Orders**

Monthly published directives from State Headquarters.

They relay ALL important News, Requirements and Activities for the State.

<u>They currently consist of 3 sections:</u>

#### **Coversheet:**

State Commander's OFFICIAL directive to all Posts & Districts in Minnesota **Program Updates:** 

State Chairman reports and timely news in a newsletter format **Attachments:** 

Documents, Flyers, and Registration Forms either due soon/of current interest.

## Who Gets them? EVERY POST

Either by email or USPS to Post Commander (or designated officer)

## What Should be Done with Them? Coversheet of the State Commander should be read at EVERY meeting.

Program Updates and Flyers should be AVAILABLE AT THE MEETING for members to view and determine if they are interested in any of the news.
