

- Tournament Dates: Friday, Saturday, Sunday, January 30 February 1, 2026
- ◆ Tournament Site: Cullen Hockey Center, 707 SE Main Ave, Moorhead, MN 56560
- Invitational Banquet Site: The Armory Event Center, 904 Center Ave, Moorhead, MN 56560
- Tournament Host: Department of Minnesota VFW and Moorhead VFW Post 1223

Photos and Rosters

Pictures and rosters for the tournament program need to be received before <u>January 1, 2026</u>. (See Enclosures A, B, and C)

State Tournament Format

- 1. The format will consist of eight (8) teams in a championship single elimination with a consolation division.
- 2. The Tournament will be made up of two Divisions (A & AA) eight (8) Teams each.
- 3. There will be games to determine consolation, third place and State Champion. **Teams in the top bracket will be the home team.**

Playing Time

Games will consist of three, 15-minute periods of actual playing time.

With a six (6) or more goal differential in the third period, the game will be played running time. The clock will only be stopped for injuries or rink problems and only at the discretion of the referee.

Overtime Procedure

In case of a tie at the end of regulation playing time, the teams shall not change goals and sudden victory overtime play will ensue using the following format:

Two (2) minute rest

First overtime period--ten (10) minutes--five on five

Resurface the ice

Second overtime period--ten (10) minutes—four on four

Two (2) minute rest

Remaining overtime periods – will be in accordance with Minnesota Hockey Rules.

Uniforms

- Every member of each team must be in proper uniform with a number and <u>at least a three</u> (3) inch V.F.W. Patch or proper identification that this is a VFW Team.
- Teams should have one set of white or light colored jerseys and one set of dark colored
 jerseys available during the scheduled game times. Arrangements should be made BEFORE the tournament starts to have two sets of different colored jerseys available in case
 of conflicts.
- (VFW Patches can be acquired through your VFW Sponsor or by calling VFW State Headquarters at 651-291-1757. Tell them to send the patches to your Team and charge your VFW Sponsor.)

Ice Resurfacing

The ice shall be resurfaced after warm-ups and after the second (2) period of each game. During the Championship game, the ice will be resurfaced between each period. In the event of Overtime, resurfacing shall occur at the end of the first overtime period and at the end of every three overtime periods thereafter.

Medical Attention

There will be an Emergency Medical Technician present at each game.

Referees

Will be used in accordance with Minnesota Hockey Rules using a 'Two Man' Referee system. If your Team objects to this system, you MUST notify Dennis Bushy and the Tournament Director by email at: bushy@moorheadyouthhockey.com and myha@moorheadyouthhockey.com

Team Registration

- * An official Certified team roster.
- * If you are electronically registered with USA Hockey, you do not need IMR forms.
- * The VFW should have received your <u>OFFICIAL Certified USA Hockey Roster</u> and your VFW Tournament Roster by the start of the Tournament. Only the Players listed on the VFW Tournament Roster will be allowed to participate in the Tournament.

Players Equipment

Limited equipment such as **mouth guards**, **stick tape**, **skate laces** are available at the rink. All players and coaches must have and wear the appropriate equipment per Minnesota and USA Hockey rules.

71st Annual Minnesota State VFW Bantam Game Instructions

ARENA CHECK-IN

Each team must check in at least one (1) hour prior to the scheduled starting time of each game. (There will be a Registration table in the Lobby.)

STARTING LINE-UP

Must be completed 30 minutes before the scheduled starting time of each game and be presented to the off-ice officials at the registration table in the lobby <u>or to the timekeeper/scorer's table at the</u> start of the five (5) minute warm-up.

Locker Rooms, Pregame Warm-ups, Introduction and National Anthem

- Please help keep the locker rooms clean. A locker room monitor for each team must be present.
- A locker room will be assigned to your Team upon your arrival. Please check the Board or Screen for your
 assigned Locker room. The coach will be offered a locker room key with the turn in of their car keys and will
 be responsible for securing the locker room.
- Moorhead Youth Hockey is NOT responsible for any items stollen from any unlocked locker rooms.
- The ice will be resurfaced after warm-ups and after each 2nd period. Teams will be notified when the ice is ready.
- Teams will have two minutes to get on the ice after being notified before the timer will start the clock for the five minute pre-game warm-up.
- After pre-game resurface the player introduction will occur.
- All players will be introduced during their first game of the Tournament, the Consolation, Third Place and Championship Games.
- Starting line-ups only will be introduced in the other tournament games.
- Home Team will go onto the ice first from the locker room and they will leave the ice first when resurfacing. Visiting team will follow.
- Losing team will leave the ice first after the game, with winning team to follow.
- The National Anthem will be played prior to each first round game and the Consolation, Third Place and Championship Game.
- Teams listed on the top bracket will be the HOME team and wear their WHITE or Light colored jerseys. Trophies and medals will be presented for 1st, 2nd, 3rd and Consolation place teams. The 4th, 5th and 6th place teams will receive a team plaque or a team trophy.


- We will respect all aspects of the game: ourselves, all coaches all officials, teammates, opponents, fans, and the rules; regardless of the behavior of others.


